9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Ken Meisle v. City and County of San
11 Francisco, San Francisco Superior Court, Case No. CGC-14-542935 by the payment of
12 \$40,000. The lawsuit involves personal injury and property damage.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 November 26, 2014, and the following parties were named in the lawsuit: Plaintiff Ken Meisle
15 and Defendant City and County of San Francisco.




