

1 [Contract Amendment - En Pointe Technologies Sales, Inc. - Technology Marketplace,
2 Tier 1A - \$50,000,000]

3 **Resolution authorizing the Office of Contract Administration to enter into the second**
4 **amendment to the contract agreement between the City and County of San Francisco**
5 **and En Pointe Technologies Sales, Inc., a Technology Marketplace, Tier 1A Generalist**
6 **contractor, to increase the contract limit from \$31,000,000 to \$50,000,000 for the period**
7 **of October 1, 2014, through September 30, 2017.**

9 WHEREAS, The Office of Contract Administration, by competitive bidding, developed
10 the Technology Marketplace procurement method for the purchase of products and services
11 related to Information Technology; and

12 WHEREAS, En Pointe Technologies Sales, Inc. is one of the six vendors who is part
13 of the Technology Marketplace, Tier1A Generalists; and

14 WHEREAS, The original contract with En Pointe Technologies Sales, Inc. dated
15 October 1, 2014, has a term of three years through September 30, 2017, with options to
16 extend the term through September 30, 2019, and has an original contract amount of
17 \$12,000,000; and

18 WHEREAS, The Board of Supervisors approved the original contract on October 1,
19 2014, by Resolution No. 362-14; and

20 WHEREAS, The Board of Supervisors approved the First Amendment to the contract
21 on July 14, 2015, by Resolution No. 260-15 to increase the contract amount from
22 \$12,000,000 to \$31,000,000; and

23 WHEREAS, The Office of Contract Administration estimates that the money
24 projected to be spent with En Pointe Technologies Sales, Inc. could reach the contract's
25 limit in the reasonably near future; and

1 WHEREAS, Charter, Section 9.118(b) "Contract and Lease Limitations," requires the
2 Board of Supervisors to approve any contract estimated to exceed \$10,000,000 in
3 expenditures or amendments exceeding \$500,000 to such contracts; now, therefore, be it

4 RESOLVED, That the Board of Supervisors authorizes the Purchaser and the Director
5 of the Office of Contract Administration to enter into the Second Amendment to the contract
6 with En Pointe Technologies Sales, Inc. in substantially the form attached to increase the
7 contract limit from \$31,000,000 to \$50,000,000; and, be it

8 FURTHER RESOLVED, That within thirty (30) days of the Second Amendment being
9 fully executed by all parties, the Office of Contract Administration shall provide the final
10 Second Amendment to the Clerk of the Board for inclusion into the official file.
