Resolution approving a Second Extension Agreement between the City and County of San Francisco, acting by and through its Public Utilities Commission, and the Modesto Irrigation District, to extend the term of the existing Long Term Energy Sales Agreement to the earlier of the approval of a replacement agreement by both parties, or June 30, 2017.

[Second Extension Agreement - Long Term Energy Sales - Modesto Irrigation District]

WHEREAS, Section 9(I) of the Raker Act obligates the City and County of San Francisco to sell or supply excess Hetch Hetchy electrical energy, upon request, to the Modesto Irrigation District (MID) for the District's municipal public purposes and irrigation pumping needs; and

WHEREAS, In 1987, San Francisco entered into a Long Term Energy Sales Agreement (LTESA) with MID; and

WHEREAS, On February 21, 2003, San Francisco and MID amended and restated the Power Sales Agreement whereby the Parties agreed to enter into a new LTESA by December 31, 2007, to continue certain provisions of their amended and restated agreement; and

WHEREAS, On October 9, 2007, by Resolution No. 07-0179, the SFPUC authorized its General Manager to execute the LTESA between the City and County of San Francisco and MID; and

WHEREAS, On December 17, 2007, by Resolution No. 689-07 this Board approved the LTESA; and

WHEREAS, The LTESA became effective on January 1, 2008, and expires on June 30, 2015; and

WHEREAS, The Parties have agreed that additional time is necessary to reach a final agreement on the terms and conditions of a new energy sales agreement and intend to extend the existing LTESA for a limited period; and

WHEREAS, On April 28, 2015, per Resolution No. 15-0099, the SFPUC approved an Extension Agreement with MID and authorized its General Manager to execute the Extension Agreement; and

WHEREAS, On June 18, 2015, by Resolution No. 226-15 this Board approved an Extension Agreement with MID; and

WHEREAS The Parties made much progress during the one-year extension but have agreed that additional time is necessary to reach final agreement on the terms and conditions of a new agreement; and

WHEREAS, On May 24, 2016, by Resolution No. 16-0103, the SFPUC approved a Second Extension Agreement with MID and authorized its General Manager to execute the Second Extension Agreement; now therefore, be it

RESOLVED, That this Board hereby approves the Second Extension Agreement between the City and County of San Francisco and MID, and authorizes the General Manager of the SFPUC to execute this Extension Agreement, pursuant to Charter, Section 9.118; and, be it

FURTHER RESOLVED, That within thirty (30) days of the Extension Agreement being fully executed by all parties the SFPUC shall provide the final Extension Agreement to the Clerk of the Board for inclusion into the official file.
