
Conditions for Type 48 On Sale General – Public Premises

- 1. Sales, service and consumption of alcoholic beverages shall be permitted only between the hours of 11:00 am to 2:00 am each day of the week.
- 2. Sales, service and consumption of alcoholic beverages in outdoor patio area shall be permitted only between the hours of 10:00 am to 10:00pm each day of the week
- 3. Noise shall not be audible beyond the area under the control of the licensee as depicted on ABC-257 dated 12/18/15.
- 4. Loitering (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the

licensed premises under the control of the licensee(s) as depicted on the ABC-257 dated 12/18/15.

- 5. The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
- 6. The licensee(s) or an employee of the licensee(s) will monitor the outdoor patio area(s) at all times that alcoholic beverages are being served or consumed.
- 7. Signs shall be posted at a conspicuous space at the entrances and/or exits of the premises as depicted on the ABC-257 dated 5/15/15 which shall state: "NO ALCOHOLIC BEVERAGES BEYOND THIS POINT." Said signs shall be no less than 7"X11" in size and contain lettering no less than 1" in height.


