[Designation of Agents Authorized to Obtain Disaster and Emergency Assistance Funding]

Resolution authorizing agents to act on behalf of the City and County of San Francisco for all matters pertaining to State and Federal Disaster and Emergency Assistance Funding.

WHEREAS, Following the Mayor's proclamation of a local emergency the City and County of San Francisco may, from time to time, be eligible for State and Federal disaster assistance funding as provided in (a) the California Disaster Assistance Act and (b) the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as Amended; and

WHEREAS, The City and County of San Francisco, per the California Governor's Office of Emergency Services, is required to designate agents authorized to obtain State and Federal disaster and emergency assistance funding and to provide the assurances and agreements required by the California Governor's Office of Emergency Services; and

WHEREAS, The Director of the Department of Emergency Management serves as the Executive Secretary of the Disaster Council and manages the Emergency Plan of the City and County; and

WHEREAS, The Controller's Office has been designated in the Emergency Plan as the lead agency for the City and County's Finance and Administration function, as per California's Standardized Emergency Management System, and is further designated as responsible for management of the recovery of costs associated with the response to and recovery from declared emergencies in the City and County of San Francisco; and

WHEREAS, This is a universal Resolution and is effective for all open and future disasters up to three (3) years following the date of this approval; now therefore be it
