[Settlement of Lawsuit - Federal Insurance Company - \$273,853.76]

Ordinance authorizing settlement of the lawsuit filed by Federal Insurance Company against the City and County of San Francisco for \$273,853.76; the lawsuit was filed on December 11, 2014, in San Francisco Superior Court, Case No. CGC-14-543173; entitled Federal Insurance Company, et al. v. San Francisco Independent Taxi Association dba Yevgeniy Komarov, et al.; the lawsuit involves a motor vehicle accident causing damage to City and adjacent real property; co-defendant and cross-defendant San Francisco Independent Taxi, doing business as Yevgeniy Komarov, will pay \$500,000.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Federal Insurance Company</u>, et al. v. <u>San Francisco Independent Taxi Association dba Yevgeniy Komarov</u>, et al., San Francisco Superior Court, Case No. CGC-14-543173 by the payment of \$273,853.76. Co-defendant San Francisco Independent Taxi dba Yevgeniy Komarov to pay \$500,000. The lawsuit involves a motor vehicle accident causing damage to City and adjacent real property.
