Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to dismiss the complaint entitled <u>City and County of San Francisco</u>, through the <u>Public Utilities Commission v. Sunol Valley Golf and Recreation Company</u>, Alameda Superior Court, Case No. RG14729649, and actions related to termination of the lease agreement entered into in September 2003 between the San Francisco Public Utilities Commission and Sunol Valley Golf and Recreation Company.

The above-named action was filed in Alameda Superior Court on June 14, 2014, as an unlawful detainer action, and amended on June 2, 2016, as a breach of contract action, and the following parties were named in the lawsuit: plaintiff City and County of San Francisco, through the Public Utilities Commission; defendant Sunol Valley Golf and Recreation Company.
