[Settlement of Lawsuit - Foo Soo Li - \$99,000]

Ordinance authorizing settlement of the lawsuit filed by Foo Soo Li against the City and County of San Francisco for \$99,000; the lawsuit was filed on June 17, 2013, in San Francisco Superior Court, Case No. CGC 13-532162; entitled <u>Foo Soo Li and Laudenia</u> <u>Pleitez v. City and County of San Francisco</u>; the lawsuit involves an employment dispute.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Foo Soo Li and Laudenia Pleitez v.</u> <u>City and County of San Francisco</u>, San Francisco Superior Court, Case No. CGC 13-532162, by the payment of \$99,000 to Foo Soo Li. The lawsuit involves an employment dispute.
