Settlement of Lawsuit and Supplemental Appropriation - Allied Insurance Company -

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Allied Insurance Company v. the City and County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-15-543789 by the payment of \$60,000.
