I have lived in Districts 5 and 6 in the neighborhoods of Hayes Valley, Cole Valley, and Haight-Ashbury (Panhandle/DMV Heights). I am a qualified patient under California medical cannabis law. I have served the medical cannabis patient community as an activist for thirteen years. I served for 2 years as an elected member of the national Board of Directors of Students for Sensible Drug Policy (SSDP), and I co-founded the SSDP chapter at the University of California Hastings College of the Law in San Francisco. In this role I received the 2010 Student Activist Award from the National Organization for the Reform of Marijuana Laws (NORML).

### Business and/or professional experience:

For 2.5 years, I have worked as an Of Counsel with Greenbridge Corporate Counsel, practicing business law exclusively for clients in California's legal medical cannabis industry. Our clients include medical cannabis collectives that provide medical cannabis to patients in SF, and ancillary companies that provide other related products and services in this industry. Prior to Greenbridge, I served for 3 years as the executive director of the Rhode Island Patient Advocacy Coalition (RIPAC), organizing the medical cannabis patient community for compassionate legislation that overcame three gubernatorial vetoes. In this role I received the August 2007 High Times Magazine Freedom Fighter of the Month award.

# **Civic Activities:**

I also serve as an anti-racist social-justice advocate with the longstanding SF-based non-profit organization Legal Services for Prisoners with Children (LSPC). In this role I assisted with the passage of the Fair Chance Ordinance (2014 enactment 017-14), initially sponsored by Supes. Kim and Cohen, to reduce the structural discrimination faced by formerly incarcerated people in the contexts of employment and housing; this ordinance was passed unanimously by the Board of Supervisors and signed by Mayor Lee. For this work with the Fair Chance Campaign we jointly received a HERO Award for Organizations Advancing Civil Rights from the SF Human Rights Commission, and a Certificate of Honor from the Board of Supervisors.

From providing free medicine to low income seriously ill patients in the 1990s, to serving on the board of the National Cannabis Industry Association (NCIA) since its inception in 2010, Erich has run the gamut of the cannabis community. Erich's contribution to the cannabis community has raised the bar for the industry while empowering countless individual patients, operators, entrepreneurs, and industry lumineers.

Seeing a dire need for those patients living with HIV/AIDS, in 2001 Erich Pearson co-founded the San Francisco Cannabis Collective. As SPARC's Development Director and President of the Board of Directors, Erich's unique ability to anticipate industry needs and develop shared solutions has been the key to SPARC's success. Erich is nationally recognized for his expertise and has a long history of collaborating with regulators and enforcers, legislators and industry associations to promote industry best practices and transparency.

# Civic Activities:

Hello, The purpose of this communication is to express interest in the Cannabis State Legalization Task Force, and to apply for a seat at the table.

My name is Brent Saupe and I currently work as a San Francisco Bay Area medical cannabis cultivation and construction consultant for no cost to low income patients, as well as helping coordinate, build and operate larger dispensing and nondispensing collective gardens.

I have been teaching others to grow their own medical cannabis, introducing patients to gardeners, and helping to facilitate compliant sustainable collective gardens for over 15 years. Thave personally been growing my own cannabis for over 30 years. An experimental San Francisco collective garden that I coordinated called Potspace, was declared by the SFWeekly to be "the best place for someone else to grow your own" in 2011.

As an ex-general contractor, I have been able to help numerous patients set up safe and legally compliant gardens in San Francisco. Building codes and city planning are just as important when considering growing cannabis in San Francisco, as knowing what law enforcement concerns are. Having experienced seven medical cannabis garden raids personally over the last fifteen years, and being "caught" following the rules each time; I have the experience, and perspective necessary to contribute to this conversation in a way that should help create continued success and compliance in San Francisco for cannabis users, law enforcement, and the building dept. alike

Seeing the importance in working to create reasonable garden guidelines that are easy for patients and law enforcement to understand, I volunteered as a member of the San Francisco Medical Cannabis Task Force, and numerous sub-committees, where we held hearings, collected public input from professionals in the field, as well as from community members, in order to create reports and give recommendations to the Board of Supervisors concerning medical cannabis issues.

I have worked with a variety of cannabis reform and community action groups including: Americans For Safe Access (ASA) since 2002, giving legal trainings and as a peer counselor in dispensaries, and in public forums teaching members how to comply with the law and how to reduce the potential harm that may occur during law enforcement encounters. I also have volunteered with the San Francisco chapter of ASA since 2002 where I helped facilitate meetings, coordinate volunteers, create fund raising opportunities, planned emergency raid responses, and rallied patients for dispensary/court support. In addition to this, I helped co-found Axis of Love, the most active and involved low income patient focused advocacy group, over a decade ago. And since I have developed a huge love and respect for the members and for the compassionate work they do every day. I have attended Glad Tidings Church in the Fillmore district for over 15 years, where I've served as a board member, feacher, handyman and janitor. I also spent two years in Bible school, and worked in inner city and low income community's in many different capacities over the last 24 years that I have lived in San Francisco. I feel this gives me an inclusive perspective of a large group of San Franciscans who may feel underrepresented during this process.

While not having an active leadership role in these for quite a few years, I have carved out -a unique place of mutual respect and communication with each of the prominent and active San Francisco cannabis organizations, and within the San Francisco faith communities as well, and would offer that because of this, I, would be a helpful addition to this task force in gathering community input in a fair and anicable fashion, and crafting reasonable rules for San Franciscans in the upcoming months as we prepare for legalization.

#### I am qualified to fill seat 9, seat 11, or seat 12.

Thank you for considering me for each of these positions. I enjoy being able to serve my community, and to do it in this way would be a joy.

## Business and/or professional experience:

Ryan Hudson is a seasoned entrepreneur with an engineering and technical background. He is a co-founder of The Apothecarium, a medical cannabis dispensary based in SF's Castro neighborhood. The Apothecarium provides safe access to lab-tested medical cannabis in a clean, professional environment. The SF Planning Department has praised The Apothecarium for its "community centered approach" and for showing how a dispensary "can successfully blend into the community." In a recent address to U.S. House of Representatives, Nevada Congresswoman Dina Titus referred to Hudson as a "leader, expert and innovator," in medical cannabis. Earlier in his career, Hudson served in network engineer roles supporting large medical device and investment bank corporations. His previous start-ups were in veterinary health, mobile apps and computer diagnostics.

## **Civic Activities:**

Hudson has led The Apothecarium's program of community philanthropy, donating more than \$300,000 dollars to more than 30 nonprofits, schools, charity/fundraiser events - mostly based in the Castro. These include: Maitri, The Family Link, Dolores Street Community Services, Brighter Beginnings, Equality California, Rocket Dog Rescue, PAWS (Pets are Wonderful Support), Rooms that Rock 4 Chemo, LYRIC, Lyon-Martin Health Services, Larkin St. Youth Center, SF Pride, SF AIDS Foundation, The Sisters of Perpetual Indulgence, AIDS Emergency Fund, The Shanti Project, Harvey Milk Civil Rights Academy.

Hudson is also an active board member of the Castro Merchants Association and the California Cannabis Industry Association. He founded 1st Saturdays, a non-profit focused on helping the homeless in San Francisco.

Dear Supervisors and Ms. Somera -

I write to recommend Kevin Reed of The Green Cross for a seat on the newly-formed Cannabis State Legalization Task Force.

**Quick introduction.** Just as background context, I am a 59 year old man with an MBA, self-employed as a financial management expert. I am grateful that I was afforded the chance to spend my career working with and in support of social and economic justice community-based nonprofit organizations. I am an extraordinarily consistent voter throughout my life (district 11, precinct 1102 although I write to ALL of you as a San Franciscan not just Supervisor Avalos). I have been a San Franciscan for just shy of 20 years on the dot.

*How I've known Kevin and his work.* I met Kevin in 2004 or so when his networking to find information about the legal parameters around CA medical cannabis dispensaries as approved by ballot measure and the associated tax filings. I have kept in close contact with Kevin and admired his surprisingly formal sense of decorum and manners and his trailblazing work on behalf of medical cannabis access ever since I became aware of all of this.

*Specific items in support.* Beyond Kevin's wealth of experience and knowledge about the filed, I have several specific "kudos" to describe about how Kevin has done his work that speak to his overall approach, and each item as well as in aggregate, demonstrate Kevin's particular preparation and aptitude for the important work of the Task Force.

- From the inception of this often fraught emergent area of commerce, Kevin has cooperated in the development of new regulatory frameworks throughout, whether the matter was zoning and locating dispensaries, regulating content standards, or licensing. By instinct, I'd hazard a guess that he's more of a libertarian, but rather than holding back, he engaged and did his best to see good laws and regulations and procedures be developed and adopted. <u>Demonstrates willingness to "play nice"</u> and be helpful not disruptive or resistant even when the formalization is not entirely in his own narrow self interest.
- Some years ago, as I was diagnosed with Type II diabetes, I talked with Kevin about fiber as the best answer to offsetting the glycemic index in many foods (other choices are fats and proteins; hydration always helps). I was not sure if he would know what to do with the idea or have time and bandwidth, but the man wastes no time! When I saw him a short 3 or 4 weeks later he'd already **developed one** "edible" aimed at a lower glycemic index by relying heavily on seeds and nuts (all three of fiber

protein & fat) and a sweetener which was asserting itself as somewhat less glycemic. <u>It was, to my</u> <u>eyes, a stunning demonstration of his responsiveness and social responsibility</u>. Of course he's no fool; it was also a new niche.

- Kevin has risked flak from various allies ("no permanent friends / no permanent enemies) and been
  on the leading edge of demanding--and inspecting for--sustainability practices and purity testing
  of crops grown by co-op members. <u>Yet another nuts and bolts demonstration of social
  responsibility, and of developing and testing what is practical by way of standards setting in these
  areas.
  </u>
- "Back home" Kevin **owned a restaurant**. He is thus **familiar with food handling requirements** and grasps innately why heath departments care about such things well beyond the hygienic standards of most home kitchens. <u>This is not so much germane to the specific work of the Task Force as much</u> <u>as a demonstration that he works for the greater good of all and understands the context of assorted</u> <u>rules, even if he grumbles on a theoretical basis he delivers</u>.
- When there arose **concerns that the gorgeous sweet edibles** just looked too darned tempting and **could be eaten by children** by mistake thereby inappropriately medicating them, Kevin once again sprang into fast action and **completely re-designed his packaging** using very adult muted colors that still looked sharp and distinctive. He did this without resisting, **even though the opaque packaging increased his cost and the overall work required** to monitor freshness and check to ensure no mold formation since no visuals available. <u>Another example of social responsibility in practice</u>.
- I was part of a small group of supporters of The Green Cross' newish storefront in the **Excelsior** who attended a **meeting of the neighborhood association along with Kevin**--complete with his usual Southern manners and pleasingly surprising insistence on a certain type of propriety required of all Green Cross representatives. This meeting was when the new location was getting final approval, and the neighborhood group was talking through the usual San Francisco mix of genuine concerns and generic NIMBYism. He did not flinch, listened carefully, and much as a victorious Presidential candidate assures the "other side" that s/he is a President of all of us, Kevin assured the neighbors that he was hearing them, and that he and his staff would act on some new items. He also repeated his assurance—as did many of us—of how much safer a block around a Green Cross location is, since he fields his own security staff and 24/7 video monitoring from multiple lenses. I attended this meeting since I live across Mission Street and Alemany in the Mission Terrace neighborhood quite close by The Green Cross storefront. I've also kept an eye on the location as I drive by very frequently, and there is a distinct increase in foot traffic and overall people presence, which is always the ultimate urban security system. *Demonstrates deep awareness of siting practicalities in one of the most difficult communities in the country with a strong emphasis on neighborhood power*.

I also am very concerned as a Mom with two male children in their teens, that the legislation not push our most vulnerable. those whose brains are still developing, to continue to use the illicit market.

#### **Civic Activities:**

In addition to my work in my community over the years, I know that cannabis clubs can benefit neighborhoods and be good neighbors, and they can, like any other business, be bad neighbors. I believe we can do a better job of culling the good from the bad and making it more possible to get rid of the bad. On the flip side after 6+ months on the task force, I'm concerned about how we are going to distribute recreational cannabis as stores are limited to a tiny squeezed green zone. I think that we are going to be seeing lots of delivery services and we should be thinking about how to do that in a way that benefits rather than harms our City.

I am also City College of San Francisco Vice President of the Board of Trustees. As such, I know how little revenue there is in CA for education. I would like to see some of the revenue raised from cannabis sales, medical or recreational, go towards education so that our system can continue to be strong with a new revenue source. One of the stated goals of Prop 64 is to lessen the harm done towards certain communities who have been incarcerated for cannabis sales. The best harm reparation that I can think of is easy access to education and support systems so that these formerly incarcerated can successfully reenter society.



I'm happy to provide a reference for my professional colleague Tom McElroy. I am a structural engineer with my own small business in San Francisco, working mainly on residential projects. 



Dear San Francisco Rules Committee,

Thank you for the opportunity to apply for Seats 9, 11, 12 & 21 on the Cannabis Legalization Task Force. As a native of San Francisco, and an advocate for medical cannabis since 2001, I would like to offer my knowledge and expertise to develop sound and sensible policies for the City of *San Francisco*.

Prior to be involved in medical cannabis, I worked as an in home care provider for mentally and physically disabled patient's, and as a chiropractic assistant in a small clinic in Potrero Hill. I was in a motor vehicle accident, four months after graduating from *SE City College* at the age of 18, where I was later diagnosed with fibromyalgia, leaving me with a range of symptoms including nerve damage, pain, chronic fatigue, & IBS. In my quest of healing, I tried dozens of medications and visited over 30 medical professionals and specialists to help ease my pain. Nothing has provided me the relief that cannabis has been able to offer.

As an advocate of medical cannabis, I was one of the founding members of the San Francisco Chapter of ASA(Americans for Safe Access). I received a patient advocacy award in Washington DC in 2013 for years of work in this industry. My work experience includes Office Manager of *Compassionate Health Options* medical cannabis clinics, Northern California Liaison for *Americans for Safe Access*, Politics & History teacher at *Oaksterdam University*, and legal assistant for two cannabis defense attorneys.

I'm confident that I can contribute a balanced and well rounded prospective based on the following:

- I'm a mother of two children: ages 5 and 8 years old.
- I was born and raised in San Francisco graduating from (bi-lingual) schools in the Mission district, and Hunters Point
- I have been a neighbor to an active dispensary (Re-leaf Center)
- I depend on medicinal cannabis for my own quality of life
- I have a good understanding of the hurdles medical cannabis dispensaries face: banking issues, federal interference, permitting & zoning issues, neighbor disputes, records,
- My interest has always been how to better serve the needs of patients
  - My goal is for San Francisco to continue to set a model for the nation to follow (as we have on the past, on so many issues)

I have serious concerns about the legalization structures that have been implemented in other states. Washington passed zero tolerance DUI laws, that make it illegal to drive with cannabis in your system. The last thing we want to do is create a system that further criminalizes activity that is considered legal. Colorado was another good example of what we do not want to replicate in California, in order to prepare for the first day of cannabis sales January 1<sup>st</sup>, there was a one time transfer of any amount of medicine from the Medical cannabis program to the recreational cannabis program. This essentially means that patients who depend on cannabis for quality of life, gifted thousands of pounds of cannabis to recreational users to get high and make money. The consequence is the patients who need this most, who may not be able to afford the medicine they need, are the ones suffering while others make money. These models should be lessons for us.

#### Qualifications for the following Seats:

Seat 9: I have worked and volunteered in the cannabis industry for over 13 years in Northern California, with professional experience working for an attorney, doctor, and the largest grassroots organization supporting medical cannabis, Americans for Safe Access.

Seat 11: I use a range of cannabis products to relive my symptoms related to fibromyalgia which I was diagnosed following a MVA in Golden Gate Park, in 2000. My interest in being a voice during medical cannabis legalization is to ensure that patients rights are preserved and that we work towards a system that does not criminalize patients based on quality of life needs.

Seat 12: I have been a cannabis advocate for over a decade in San Francisco, working with *San Francisco ASA* & *Medical Cannabis Task Force* (as well as the *working group* that created the task force), my exposure to cannabis in San Francisco began as early as middle school, I can contribute balanced solutions based on a range of experiences in San Francisco.

Seat 21: While I consider myself no public policy expert, I have worked at the local, state, and federal level to help develop ordinances, bills, and congressional solutions to our current hurdles on medical cannabis. Working towards sensible regulation I have had the opportunity to work with city councils, board of supervisors, sheriff, narcotics, department of public health, planning departments, and retired politicians. *Americans for Safe Access*, working in alliance with *American Herbal Products Association* (the regulatory agency for all medicinal plants & herbs) have developed a monograph, and standards for distribution, manufacturing, testing, and cultivation. I support AHPA's regulation and look forward to any steps that may remove cannabis from the Controlled Substance Act. I recognize our current legal system unequally affects low income individuals and people of of color.

As a patient born and raised in San Francisco, my interest is to maintain good standards, as San Francisco has always served as a model for the nation.

> I am writing this letter to reiterate our concerns regarding this taskforce. Our previously expressed concerns regarding possible illegal lobbying efforts and possible illegal campaign efforts by this taskforce for both the Scott Weiner State Senate race and Prop 64 are becoming more serious with the developments of the past few weeks.

> Several articles have promoted Supervisor Weiner, despite the fact that this taskforce is a government entity paid for by the People. It is our understanding that such activities are prohibited by law and that this taskforce and other government agencies are prohibited from political campaigning for ballot initiatives with taxpayer money.

> I feel that this taskforce has been used to openly promote Prop 64 and has now even restricted its own members from engaging in public opposition to Prop 64 during their own private, off-duty time.

> Again, I reiterate, to our understanding this is in direct violation of California law.

> Prop64 is a controversial issue with the state-wide cannabis stakeholders, the Small Farmers Association, and many private citizens. One of the largest farmers' association is not coming out in support of this ballot initiative, many large and well-recognized organizations are openly opposing it and many citizens are campaigning against it. Despite the clear division in California's voters, this taskforce is acting as if this ballot measure is already written law in defiance of its purpose, thus purposely misleading San Francisco's agencies and voters. Was not this taskforce created to consider all contingencies for the benefit of our public? At the very least this is an ethical violation and a failure to meet its purpose.

>

> Our group represents just one of many who oppose this issue—not because we oppose the idea of

legalization, but because we oppose the many injustices that will arise against the citizens of this state should the ballot measure pass. Prop 64 outlaws compassion by denying open sharing and cooperation for the production of affordable medicine for those who are sickest and most in need. Prop 64 also has components that will adversely impact the African American community, as well as other disabled and low-income demographics. We feel that it is therefore in direct conflict with many stated policy directives of our City.

> Now, Michelle Aldrich, a matriarch of our City's cannabis community has now vacated her position from this taskforce. Did she leave this taskforce as a result of the taskforce's propensity to stifle differing opinions? Is this yet another red flag that something more broad is amiss with these already questionable efforts?

> It is time for this City to begin an investigation into these matters. The first matter of concern must be inquiries into the fact that this taskforce is being used as an unfair campaign tool. An equally important matter of investigation is that this force is being used to manufacture consent and bolster the career efforts of lobbyists.

> We do not simply object to these actions because the taskforce is being used to push a proposition that would further restrict cannabis rights in a city that has, by law, established itself as a sanctuary for those patients most in need. We object to these illegal actions on the sheer basis that there is a reason that California has made these types of government-backed campaign activities illegal. Use of vast taxpayer funds and government resources for the manipulation of public opinion, whether blatant or subtle, would lead to great injustice for the most vulnerable members of our state who can ill-afford to compete with such resources, no matter what issue was at stake.

Furthermore, the rights of individual officers of any government agency to participate in political activity during their own private time are specifically enumerated by State law. (See Cal. Gov't Code Sec. 3203.)

<u>Report</u>: No later than one year after its inaugural meeting, and at least once in the 12 months thereafter, the Task Force shall submit a report to the Board of Supervisors describing the legislative activity in the State Legislature regarding possible legalization of cannabis; findings regarding legal, social, land use, and enforcement issues that are likely to arise in San Francisco if the State adopts proposed legislation through the legislative or electoral process; and recommendations regarding local implementation and enforcement of that potential legislation.

<u>Sunset Date</u>: The Task Force shall sunset on August 14, 2017, unless the Board of Supervisors extends the term by ordinance.

The Task Force consists of 22 members (seats 1 through 7 shall be non-voting members):

#### DEPARTMENT HEAD MEMBERS

- > Seat 1: Director of the Department of Public Health, or his/her designee
- > Seat 2: Chief of the Fire Department, or his/her designee
- > Seat 3: Chief of the Police Department, his/her designee
- > Seat 4: Director of the Department of Building Inspection, or his/her designee
- > Seat 5: Director of Planning, or his/her designee
- > Seat 6: Executive Director of the Entertainment Commission, or his/her designee

> Seat 7: Executive Director of the California Board of Equalization, or his/her designee (if the Executive Director declines and fails to appoint a designee for 60 days or longer, the Board of Supervisors may appoint a member of the public)

> Seat 8: Superintendent of the San Francisco Unified School District, or his/her designee which may include a Member of the Board of Education (if the Superintendent declines and fails to appoint a designee for 60 days or longer, the Board of Supervisors may appoint a member of the public)

> Seat 9: Must be an individual with at least two years of experience working in the cannabis industry.

> Seat 12: Must be an individual who uses cannabis and has at least two years of cannabis legalization advocacy experience.

> Seat 13: Must be an owner of a small business in San Francisco.

> Seat 14: Must be an individual with experience working for, or on behalf of, the interests of businesses in San Francisco.

> Seat 15: Must be an individual with experience working to advance the tourism or hospitality industry in San Francisco.

> Seats 16 and 17: Must be individuals who represent neighborhood associations.

> Seat 18: Must be an individual with experience in public health advocacy focusing on drug policy.

> Seat 19: Must be an individual working in the entertainment or nightlife industry.

> Seat 20: Must be a representative of a labor union that represents employees working in the cannabis industry.

> Seat 21: Must be a public policy expert working for an organization focused on the formulation of good public policy.

> Seat 22: Must be an individual between the ages of 21 and 30 at the time of appointment.

The Public Members in seats 9 through 22 shall serve for a term of one year. The initial term for each seat shall begin on August 31, 2015. At the end of the one-year term, the Board of Supervisors may reappoint the member by written motion without soliciting applications from additional applicants.

The Department of Public Health shall provide clerical and administrative support and staffing for the Task Force. The Task Force shall hold a regular meeting not less than five times per year.
