[Settlement of Lawsuit and Supplemental Appropriation - CSAA Insurance Exchange -\$700,0001

Ordinance authorizing settlement of the lawsuit filed by CSAA Insurance Exchange against the City and County of San Francisco for \$700,000; the lawsuit was filed on June 17, 2014, in San Francisco Superior Court, Case No. CGC-14-539993; entitled CSAA Insurance Exchange v. City and County of San Francisco, et al.; the lawsuit involves alleged property damage arising from the break of the Public Utilities Commission's water transmission pipeline on 15th Avenue between West Portal Avenue and Wawona Street in San Francisco; and appropriating \$700,000 from the Water Enterprise fund balance for such purpose.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled CSAA Insurance Exchange v. City and County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-14-539993 by the payment of \$700,000. The lawsuit involves alleged property damage from the break of the SFPUC's water transmission pipeline on 15th Avenue between West Portal Avenue and Wawona Street in San Francisco.

Section 2. The above-named action was filed in San Francisco Superior Court on June 17, 2014, and the following parties were named in the lawsuit: Plaintiff: CSAA Insurance Exchange, Defendants: City and County of San Francisco and Precision Engineering, Inc.

Section 3. The Board herein appropriates \$700,000 from the Water Enterprise fund balance for use by the San Francisco Public Utilities Commission for purposes of settling the litigation.
