Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Administrative Code Section 10.22, the Board of Supervisors hereby authorizes the City Attorney to settle the claim made by the California Department of Fish and Wildlife, Office of Spill Prevention and Response against the City and County of San Francisco on December 30, 2014, by the payment of \$300,263.26. The claim concerns three separate incidents of chlorinated water discharges into San Mateo Creek by the San Francisco Public Utilities Commission on October 3 and 24, 2012, and on February 9, 2013.

Section 2. The Board appropriates \$300,263.26 from the Water Enterprise fund balance for use by the San Francisco Public Utilities Commission for purposes of settling the State's claim.
