15	Be it ordained by the People of the City and County of San Francisco:
16	
17	Section 1. Findings.
18	(a) The Planning Department has determined that the actions contemplated in this
19	ordinance comply with the California Environmental Quality Act (California Public Resources
20	Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
21	Supervisors in File No. 161095 and is incorporated herein by reference. The Board affirms
22	this determination.
23	(b) On September 8, 2016, the Planning Commission, in Resolution No. 19730, adopted
24	findings that the actions contemplated in this ordinance are consistent, on balance, with the
25	City's General Plan and eight priority policies of Planning Code Section 101.1. The Board

1	adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the
2	Board of Supervisors in File No. 161095, and is incorporated herein by reference.
3	
4	Section 2. The Planning Code is hereby amended by revising Sectional Map HT08 of
5	the Zoning Map of the City and County of San Francisco as follows:

7	Height & Bulk District Height and Bulks District <u>Description of Property</u> <u>to be Superseded</u> <u>here by Approved</u>
8	Block 4277, Lot 016 OS (Open Space) 40-X
9	
10	
11	Section 3. Effective Date. This ordinance shall become effective 30 days after
12	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
13	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
14	of Supervisors overrides the Mayor's veto of the ordinance.
