5 **Francisco Superior Court, Case No. CGC-15-545729; entitled Leland Castro v. City and**
6 **County of San Francisco, et al.; the lawsuit involves alleged personal injury on a City**
7 **sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Leland Castro v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-15-545729 by the
13 payment of \$200,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 May 7, 2015, and the following parties were named in the lawsuit: Plaintiff: Leland Castro;
16 Defendants: Graham Bennett, Yet Hong Yee as Trustee of the Trust of Yet Hong Yee, City
17 and County of San Francisco, Pacific Gas and Electric Company.




