9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled City and County of San Francisco v. In  
12 and Out Drain Cleaning, Inc., et al., San Francisco Superior Court, Case No. CGC-15-544912  
13 by the payment of \$38,500 by In and Out Drain Cleaning, Inc. The lawsuit involves a ruptured  
14 water main.

15 Section 2. The above-named action was filed in San Francisco Superior Court on  
16 March 24, 2015, and the following parties were named in the lawsuit: Plaintiff City and County  
17 of San Francisco; Defendants In and Out Drain Cleaning, Inc., dba In & Out Plumbing; Dale  
18 Brown, dba Dale's Excavating.
