MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated persons to serve as members of the Workforce Community Advisory Committee, pursuant to the provisions of Administrative Code, Article II, Sections 5.2-1 through 5.2-7, for the terms specified:

Elizabeth Jackson-Simpson, seat 1, new appointment, must be, at the time of their appointment, employed by a nonprofit corporation that provides workforce development services and must be the executive director or chief executive officer, or an employee of the nonprofit corporation designated by such person; shall have demonstrated experience in leadership roles in workforce development, as well as expertise (preferably at federal, state, and local levels) in workforce development policy and systems, for a two-year term ending October 25, 2018.

Debra Gore-Mann (residency requirement waived), seat 2, new appointment, must be, at the time of their appointment, employed by a nonprofit corporation that provides workforce development services and must be the executive director or chief executive officer, or an employee of the nonprofit corporation designated by such person; shall have demonstrated experience in leadership roles in workforce development, as well as expertise (preferably at federal, state, and local levels) in workforce development policy and systems, for a two-year term ending October 25, 2018.

Villy Wang, seat 3, new appointment, must be, at the time of their appointment, employed by a nonprofit corporation that provides workforce development services and must be the executive director or chief executive officer, or an employee of the nonprofit corporation designated by such person; shall have demonstrated experience in leadership roles in workforce development, as well as expertise (preferably at federal, state, and local levels) in workforce development policy and systems, for a two-year term ending October 25, 2018.

FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 1. The membership of the Workforce Community Advisory Committee has a goal to be representative of the diversity of the City and County of San Francisco.
- 2. Applicant Debra Gore-Mann, who is not a resident of San Francisco, is a person with experience that uniquely qualifies her to serve on the Workforce Community Advisory Committee.
- 3. The Workforce Community Advisory Committee has attempted to fill the position, for which Jennifer Garcia was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Jennifer Garcia is qualified to serve on the Workforce Community Advisory Committee.
- 4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco, and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Workforce Community Advisory Committee at this time; and, be it

FURTHER MOVED, That the Board of Supervisors waives the residency requirement for Debra Gore-Mann, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Charter, Section 4.101(a)(2), that requires person(s) appointed to

boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
