[Waiver Permitting City Employees to Assist the Department of Elections with the November 8, 2016 Election]

Motion granting a waiver from the prohibition imposed by Charter, Section 13.104.5, to permit City employees to assist the Department of Elections with the November 8, 2016, election.

WHEREAS, San Francisco Charter, Section 13.104.5 prohibits City employees and officers (other than the Director of Elections, an appointee of the Director of Elections or a member of the Elections Commission) from performing "any function relating to the conduct of an election;" and

WHEREAS, Charter, Section 13.104.5 authorizes the Board of Supervisors, upon the request of the Elections Commission, to waive this prohibition by motion; and

WHEREAS, On September 21, 2016, the Elections Commission requested that the Board of Supervisors waive this prohibition to permit City employees to assist the Department of Elections with the November 8, 2016, election; now, therefore, be it

MOVED, That the Board of Supervisors waives the prohibition imposed by Charter, Section 13.104.5, to permit City employees to assist the Department of Elections before, during and after the November 8, 2016 election.
