3 **Resolution determining that the issuance of a Type 64 general theatre license to**  
4 **Boxcar Theatre, Inc. dba Boxcar Theatre, located at 644 Broadway Street (District**  
5 **3), will serve the public convenience or necessity of City and County of San**  
6 **Francisco in accordance with California Business and Professions Code, Section**  
7 **23958.4, and recommending that the California Department of Alcoholic Beverage**  
8 **Control impose conditions on the issuance of the license.**

10 WHEREAS, Boxcar Theatre, Inc. is seeking the issuance of a Type 64 general  
11 theatre license dba Boxcar Theatre located at 644 Broadway Street (District 3); and

12 WHEREAS, The Planning Department has verified that the area is properly  
13 zoned and recommends approval; and

14 WHEREAS, The Police Department has filed zero (0) protests with the  
15 Department of Alcoholic Beverage Control under California Business and Professions  
16 Code, Section 24013, and recommends that the Department of Alcoholic Beverage  
17 Control issue the liquor license with conditions; and

18 WHEREAS, The conditions recommended by the Police Department are the  
19 following: 1) Loitering (defined as "to stand idly about; linger aimlessly without lawful  
20 business") is prohibited on any sidewalks or property adjacent to the licensed premises  
21 under the control of the licensee as depicted on the ABC-257; 2) no noise shall be  
22 audible beyond the area under the control of the licensee as define on the ABC-257; 3)  
23 the sale of alcoholic beverages for off-sale consumption is strictly prohibited; and 4)  
24 alcoholic beverages shall be served in containers which significantly differ in

1 appearance from those containers utilized for non-alcoholic beverages. Containers for  
2 beer shall not exceed 16 ounces; now, therefore, be it

3 RESOLVED, That in accordance with California Business and Professions Code,  
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
5 hereby determines that the issuance of a Type 64 general theatre license to Boxcar  
6 Theatre, Inc. dba Boxcar Theatre located at 644 Broadway Street (District 3), will serve  
7 the public convenience or necessity of the City and County of San Francisco; and, be it

8 FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
9 San Francisco hereby endorses and adopts the recommendations of the Police  
10 Department listed above and recommends that the Department of Alcoholic Beverage  
11 Control issue the license with those conditions.


