

1 [Accept and Expend Grant - California Governor's Office of Emergency Services, Elder
2 Abuse Program - \$400,000]

3 **Resolution retroactively authorizing the Office of the District Attorney to accept and**
4 **expend a grant in the amount of \$400,000 from the California Governor's Office of**
5 **Emergency Services for the Elder Abuse Program for the grant period July 1, 2016,**
6 **through June 30, 2018.**

8 WHEREAS, The Office of the District Attorney applied for funding from the California
9 Governor's Office of Emergency Services for the "Elder Abuse (XE) Program" and was
10 awarded Four Hundred Thousand dollars (\$400,000); and

11 WHEREAS, The purpose of the grant is to enhance the safety of elder victims of
12 crime by providing direct services to victims, and bridge the gap between elder justice
13 service providers and victim service providers; and

14 WHEREAS, The grant does not require an amendment to the Annual Salary
15 Ordinance (ASO) Amendment; and

16 WHEREAS, The grant includes a required match of 20% of the project budget or
17 \$100,000; the source of match is through volunteer hours and general funds; and

18 WHEREAS, The grant includes provision for indirect costs of \$19,827; now,
19 therefore, be it

20 **RESOLVED**, That the Board of Supervisors hereby authorizes the Office of the
21 District Attorney to retroactively accept and expend, on behalf of the City and County of
22 San Francisco, a grant from the California Governor's Office of Emergency Services for the
23 Elder Abuse Program in the amount of \$400,000 to enhance elder services.
