3 **Ordinance authorizing settlement of the lawsuit filed by Fosco Zilli and Silvia Vojtkova-**
4 **Zilli against the City and County of San Francisco for \$60,000; the lawsuit was filed on**
5 **April 1, 2015, in San Francisco Superior Court, Case No. CGC-15-545063; entitled Fosco**
6 **Zilli and Silvia Vojtkova-Zilli v. City and County of San Francisco, et al.; the lawsuit**
7 **involves plaintiffs' vehicle allegedly being rear-ended by a City vehicle.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Fosco Zilli and Silvia Vojtkova-Zilli v.
12 City and County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-15-
13 545063 by the payment of \$60,000. The lawsuit involves plaintiffs' vehicle allegedly being
14 rear-ended by a City vehicle.

15 Section 2. The above-named action was filed in San Francisco Superior Court
16 on April 1, 2015, and the following parties were named in the lawsuit: Plaintiffs: Fosco Zilli
17 and Silvia Vojtkova-Zilli; Defendants: City and County of San Francisco and Terry Lee Major.






