Resolution authorizing the Controller to enter into the tenth amendment of a software license and support agreement with JobAps, Inc., increasing the contract term of November 27, 2006, through November 26, 2016, by two years through November 26, 2018, and increasing the maximum expenditure by \$612,350 to an amount not to exceed \$2,237,020.

WHEREAS, On November 27, 2006, the City and County of San Francisco ("City"), acting through its Controller, entered into an Agreement with JobAps, Inc. ("JobAps"), for a hosted application for web-based job application recruitment, testing, certification and referral services ("Agreement"); and

WHEREAS, The initial term of this Agreement was for three years, with two options to extend at the City's option for a period of two years, and the initial maximum expenditure was \$250,000; and

WHEREAS, The Controller and JobAps amended the Agreement by the First
Amendment, dated January 20, 2009; Second Amendment, dated December 1, 2009; Third
Amendment, dated January 3, 2011; Fourth Amendment, dated August 1, 2011; Fifth
Amendment, dated January 1, 2012; Sixth Amendment, dated August 7, 2012; Seventh
Amendment, dated January 1, 2013; Eighth Amendment, dated November 1, 2013; and Ninth
Amendment, dated December 1, 2014, extending the term to November 26, 2016, and
increasing the maximum expenditure to \$1,624,670; and

WHEREAS, By the Tenth Amendment the Controller and JobAps have agreed to extend the term to November 26, 2018, and increase the maximum expenditure by \$612,350 to \$2,237,020 for continued software support services; and

WHEREAS, The Controller has determined that it is in the best interests of the City to extend the term of the Agreement beyond ten years and increase the maximum expenditure to \$2,237,020, so that the City may continue to receive software support services; and

WHEREAS, Charter, Section 9.118(b), "Contract and Lease Limitations," requires Board of Supervisors' approval of any contract having a term in excess of ten years or requiring anticipated expenditures by the City of \$10,000,000; and

WHEREAS, The Tenth Amendment is on file with the Clerk of the Board of Supervisors in File No. 160956, which is hereby declared to be a part of this motion as if set forth fully herein; now, therefore, be it

RESOLVED, That the Board of Supervisors approves the Tenth Amendment to the Agreement with JobAps; and, be it
