9 WHEREAS, The Board of Supervisors' Rules of Order 3.26 requires that all proposed  
10 measures concerning appointments shall be referred to the Rules Committee for public  
11 hearing and recommendation; and


12 WHEREAS, Board Rule 5.2 allows Board Rule 3.26 to be suspended by the affirmative  
13 vote of eight Board Members, unless there are fewer than eight Board Members present, in  
14 which case the unanimous consent of the Board Members present, but not fewer than six  
15 Board Members, shall be required; and

16 WHEREAS, Due to the holiday cancellations of the Rules Committee regular meetings  
17 on November 10, 2016, and November 24, 2016, the Board Members wish to suspend the  
18 operation of Rule 3.26, with regard to the consideration of appointments at the Rules  
19 Committee; and

20 WHEREAS, The hearing to consider an appointment to the Park, Recreation and Open  
21 Space Advisory Committee can be found in Board of Supervisors File No. 161191; now,  
22 therefore, be it

23 MOVED, That the Board of Supervisors of the City and County of San Francisco, as  
24 allowed by Board Rule 5.2, hereby suspends the operation of Board Rule 3.26 to consider an  
25 appointment at the Government Audit and Oversight Committee; and, be it

1 FURTHER MOVED, That the consideration of an appointment to the Park, Recreation  
2 and Open Space Advisory Committee (File No. 161191) shall be referred to the Government  
3 Audit and Oversight Committee and heard at the regular meeting on November 17, 2016.


