3 **Ordinance amending the Campaign and Governmental Conduct Code to update the**  
4 **Conflict of Interest Code’s Form 700 (Statement of Economic Interests) filing**  
5 **requirements for the City, the San Francisco Community College District, the San**  
6 **Francisco Unified School District, and the Successor Agency to the Redevelopment**  
7 **Agency, by adding, deleting, and changing titles of designated officials and employees**  
8 **to reflect organizational and staffing changes, and by refining disclosure requirements**  
9 **for designated officials and employees.**

17 Be it ordained by the People of the City and County of San Francisco:

18 Section 1. The Campaign and Governmental Conduct Code is hereby amended by  
19 revising Sections 3.1-103, 3.1-120, 3.1-150, 3.1-155, 3.1-158, 3.1-160, 3.1-163, 3.1-165, 3.1-  
20 175, 3.1-190, 3.1-205, 3.1-207, 3.1-218, 3.1-230, 3.1-250, 3.1-251, 3.1-252, 3.1-253, 3.1-267,

3 the official title of the ordinance.
