#### MOTION NO.

[Preparation of Findings to Reverse the Categorical Exemption Determination - Proposed Project at 203 Cotter Street]

Motion directing the Clerk of the Board to prepare findings reversing the determination by the Planning Department that a proposed project at 203 Cotter Street is categorically exempt from further environmental review.

WHEREAS, On September 27, 2016, the Planning Department determined that the proposed project located at 203 Cotter Street ("Project") is exempt from further environmental review under the California Environmental Quality Act ("CEQA"), the CEQA Guidelines, and Administrative Code, Chapter 31; and

WHEREAS, The proposed involves removing a neighborhood agricultural use from the site and constructing a new kindergarten through 8th grade private school campus (the Golden Bridges School) that would enroll up to 200 students and 30 full- or part-time staff and include a two-story building, totaling approximately 15,400 square feet; and

WHEREAS, By letter to the Clerk of the Board, received by the Clerk's Office on October 27, 2016, Nancy Huff, on behalf of the Mission Terrace Land Preservation Committee (Appellant), appealed the exemption determination; and

WHEREAS, Appellant provided a copy of the Planning Department's Categorical Exemption Determination, signed September 27, 2016, which found that the proposed project was exempt under Class 32 of the CEQA Guidelines (14 Cal. Code Reg., Section 15332); and

WHEREAS, The Planning Department's Environmental Review Officer, by memorandum to the Clerk of the Board dated November 1, 2016, determined that the appeal was timely filed because the Planning Commission, by Motion No. 19751 on September 29, 2016, approved a conditional use authorization for the proposed project; and

Clerk of the Board BOARD OF SUPERVISORS WHEREAS, On December 6, 2016, this Board held a duly noticed public hearing to consider the appeal of the exemption determination filed by Appellant and, following the public hearing, reversed the exemption determination subject to the adoption of written findings in support of such determination; and

WHEREAS, In reviewing the appeal of the exemption determination, this Board reviewed and considered the exemption determination, the appeal letter, the responses to the appeal documents that the Planning Department prepared, the other written records before the Board of Supervisors and all of the public testimony made in support of and opposed to the exemption determination appeal; and

WHEREAS, Following the conclusion of the public hearing, the Board of Supervisors conditionally reversed the exemption determination for the project subject to the adoption of written findings of the Board in support of such determination based on the written record before the Board of Supervisors as well as all of the testimony at the public hearing in support of and opposed to the appeal; and

WHEREAS, The written record and oral testimony in support of and opposed to the appeal and deliberation of the oral and written testimony at the public hearing before the Board of Supervisors by all parties and the public in support of and opposed to the appeal of the exemption determination is in the Clerk of the Board of Supervisors File No. 161216 and is incorporated in this motion as though set forth in its entirety; now, therefore, be it

MOVED, That the Board of Supervisors directs the Clerk of the Board to prepare the findings specifying the basis for its decision on the appeal of the exemption determination issued by the Planning Department for the project.
