Seat 1, succeeding L. Julius Turman, term expires April 30, 2019, must be nominated by the Board of Supervisors' Rules Committee and subject to confirmation by the Board of Supervisors, for a four-year term.

Vacant seat 2, succeeding Victor Hwang, resigned, must be nominated by the Board of Supervisors' Rules Committee and subject to confirmation by the Board of Supervisors, for the unexpired portion of a four-year term ending April 30, 2018.

Seat 3, succeeding Petra DeJesus, term expires April 30, 2017, must be nominated by the Rules Committee or its successor and subject to confirmation by the Board of Supervisors, for a four-year term.

Seat 6, Joseph Marshall, term expires April 30, 2018, must be nominated by the Mayor and subject to confirmation by the Board of Supervisors, for a four-year term.
