Ordinance amending the Administrative Code to codify the Balboa Park Station Area				
Plan Community Advisory Committee, establish its size and membership, set terms				
and term limits for its members, and extend its sunset date to February 28, <u>2019</u> 2020.

Be it ordained by the People of the City and County of San Francisco:				
Section 1. The Administrative Code is hereby amended by adding Article XII, Sections				
5.12-1 through 5.12-7, to Chapter 5, to read as follows:				
<u>SEC. 5.12-1. CREATION OF BALBOA PARK STATION AREA PLAN COMMUNITY</u>				
ADVISORY COMMITTEE. The Board of Supervisors hereby establishes the Balboa Park Station Area Plan Community				
Advisory Committee (the "Committee") of the City and County of San Francisco.				
<u>SEC. 5.12-2. FINDINGS.</u>				
(a) In April 2009, the City enacted Ordinance No. 60-09, amending the City's General Plan				
to implement the Balboa Park Station Area Plan ("BPSAP"). At the same time, the City enacted				
Ordinance Nos. 58-09, 59-09, and 61-09 to effectuate the BPSAP. The BPSAP identified potential				
changes to improve the plan area's public realms; to promote a balanced mix of public benefits and				
infrastructure improvements in and around the BART station, Upper Yard, Geneva Plaza, and				

Supervisor Avalos BOARD OF SUPERVISORS transportation areas; to improve pedestrian safety and overall area security; and to ensure that new neighborhood infrastructure is provided concurrently with the demands generated by the BPSAP.

(b) In March 2012, the City enacted Resolution No. 063-12, establishing the Balboa Park Community Advisory Committee for the purpose of providing input and community oversight on the prioritization and implementation of the transportation and other public improvements envisioned in the BPSAP; relaying information to community stakeholders; and serving as a forum for coordination, information-sharing, and collaboration among neighborhood residents, City agencies, and developers. In December 2014, the City enacted Resolution No. 458-14, extending the Committee for two additional years. This Article XII codifies the Committee in the Administrative Code.

## SEC. 5.12-3. MEMBERSHIP.

(a) The Committee shall consist of nine members, appointed by the Board of Supervisors.
 (1) Seat 1 shall be held by a person who is a member of or an advocate for low-

income or underserved communities in the neighborhoods served by Balboa Park Station.

(2) Seat 2 shall be held by a person who represents or is an advocate for families and young people, inlcuding youth ages 16 to 24, in the neighborhoods served by Balboa Park Station.

(3) Seat 3 shall be held by a student, faculty member or staff member at City College of San Francisco or another school served by Balboa Park Station.

(4) Seat 4 shall be held by a person who is senior or disabled or who advocates for senior or disabled communities in the neighborhoods served by Balboa Park Station.

(5) Seat 5 shall be held by a person who regularly rides public transit or who advocates for transit riders in the neighborhoods served by Balboa Park Station.

(6) Seat 6 shall be held by a person who advocates for the interests of pedestrians and bicyclists in the neighborhoods served by Balboa Park Station. (7) Seat 7 shall be held by a resident of the neighborhoods served by Balboa Park Station.

(8) Seat 8 shall be held by a person who owns or works for a small business or who advocates for community and economic development in the neighborhoods served by Balboa Park Station.

(9) Seat 9 shall be held by a representative of a nonprofit organization or community group that works on issues related to land use or housing in the neighborhoods served by Balboa Park Station.

(b) The members of the Committee generally should have a variety of diverse capacities and backgrounds, representing the diversity of the communities served by the Balboa Park Station.

# SEC. 5.12-4. ORGANIZATION AND TERMS OF OFFICE.

(a) The terms of all members of the Committee shall expire by operation of law on February 28, 2017. Thereafter, members of the Committee shall serve two-year terms beginning on March 1, 2017; provided, however, in order to stagger the terms of the members, the term of the initial

appointees in Seats 2, 4, 6, and 8 shall be one year and shall expire on February 28, 2018.

(b) No person may serve more than two successive terms as a member of the Committee beginning on or after March 1, 2017. No person having served two successive terms may serve as a member until at least two years after the expiration of the second successive term. For purposes of this subsection (b), service for a part of a term that is more than half the period of the term shall count as a full term, and service that is half or less than half the period of a term shall not count as a full term; further, this subsection makes no distinction between the initial one-year terms described in subsection (a) and two-year terms.

(c) Each member shall serve at the pleasure of the Board of Supervisors.

(e) Members of the Committee shall receive no compensation from the City.

(f) Any member who misses three regular meetings of the Committee without the express approval of the Committee at or before each missed meeting shall be deemed by operation of law to have resigned from the Committee ten days after the third unapproved absence. The Committee shall inform the Clerk of the Board of Supervisors of the resignation.

(g) The Board of Supervisors urges the Municipal Transportation Agency to provide clerical and administrative support and staffing for the Committee.

(a) The Committee shall provide advice to the Board of Supervisors, the Mayor, and all relevant City departments regarding implementation of the BPSAP. The Committee shall monitor the progress of public improvement projects in the area, and provide advice regarding how the City can prioritize projects to maximize community improvement. The Committee shall conduct outreach to communities in the neighborhoods served by the Balboa Park Station with the goal of ensuring robust public participation at Committee meetings.

(b) By January 31 each year, the Committee shall develop a work plan to guide the Committee's priorities and agendas for that year.

(c) All City departments, commissions, boards, and agencies shall cooperate with the Committee in conducting its business.

#### SEC. 5.12-6. MEETINGS AND PROCEDURES.

(a) The Committee shall hold a regular meeting not less than once every three months until the sunset date set forth in Section 5.12-7. The Committee shall meet no more than a maximum of six times per calendar year.

(b) Five members of the Committee shall constitute a quorum for the purpose of meeting, and the affirmative votes of at least five members of the Committee are necessary to constitute approval of any non-parliamentary matter by the Committee.

(c) The Committee shall elect its own officers and may establish rules for its own organization and procedures.

## <u>SEC. 5.12-7. SUNSET.</u>

Unless extended by ordinance, this Article XII shall expire by operation of law, and the Committee shall terminate, on February 28, 20192020. After the expiration of the Committee, the City Attorney shall cause this Article to be removed from the Administrative Code.

Section 2. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

## **Board Qualifications:**

The Board of Supervisors established the Balboa Park Station Community Advisory Committee (CAC) for the purpose of providing input and community oversight on the prioritization and implementation of transportation and other public improvements; relaying information to community stakeholders; and serving as a forum for coordination, information-sharing, and collaboration between community, transportation agencies, and developers.

The CAC is charged with providing input to ensure balanced implementation of the plans for the Balboa Park Station Area, guide prioritization, and oversee timely progress of public improvement projects. The CAC shall monitor the progress of the San Francisco Municipal Transportation Agency (SFMTA), the Bay Area Rapid Transit District (BART), the Transportation Authority (SFCTA), and the San Francisco Planning Department (Planning) in advancing plans and public improvement projects; track project development responsibilities and timelines, collaborate with transportation agencies and the Planning Department to prioritize community improvement projects and help seek funding for high priority projects.

The Committee shall consist of nine members, appointed by the Board of Supervisors:
Seat 1 shall be held by a person who is a member of or an advocate for low-income or underserved communities in the neighborhoods served by Balboa Park Station.
Seat 2 shall be held by a person who represents or is an advocate for families and young people, inlcuding youth ages 16 to 24, in the neighborhoods served by Balboa Park Station.
Seat 3 shall be held by a student, faculty member or staff member at City College of San

Francisco or another school served by Balboa Park Station.

- Seat 4 shall be held by a person who is senior or disabled or who advocates for senior or disabled communities in the neighborhoods served by Balboa Park Station.

- Seat 5 shall be held by a person who regularly rides public transit or who advocates for transit riders in the neighborhoods served by Balboa Park Station.

- Seat 6 shall be held by a person who advocates for the interests of pedestrians and bicyclists in the neighborhoods served by Balboa Park Station.

- Seat 7 shall be held by a resident of the neighborhoods served by Balboa Park Station.

Seat 8 shall be held by a person who owns or works for a small business or who advocates for community and economic development in the neighborhoods served by Balboa Park Station.
Seat 9 shall be held by a representative of a nonprofit organization or community group that works on issues related to land use or housing in the neighborhoods served by Balboa Park Station.

The members of the Committee generally should have a variety of diverse capacities and backgrounds, representing the diversity of the communities served by the Balboa Park Station.

No person may serve more than two successive terms as a member of the Committee beginning on or after March 1, 2017. No person having served two successive terms may serve as a member until at least two years after the expiration of the second successive term.

The Committee shall hold a regular meeting not less than once every three months until the sunset date set forth in Section 5.12-7. The Committee shall meet no more than a maximum of six times per calendar year.

The Board of Supervisors urges the Municipal Transportation Agency to provide clerical and administrative support and staffing for the Committee.

Reports: None.

Sunset Date: The CAC was originally scheduled to sunset two years after the date of the first meeting (January 9, 2015). On December 9, 2014, the Board of Supervisors adopted Resolution No. 458-14, which extended the CAC an additional two years from the date of the first meeting in 2015. On, November 22, 2016, the Mayor signed Ordinance No. 235-16, which extended the sunset of the Committee until February 28, 2019.
