WHEREAS, The Board of Supervisors Rules of Order, Section 4.2, states the Board shall hold a regular meeting in the Legislative Chamber in City Hall each Tuesday at 2:00 p.m., unless it is a holiday, in which case the meeting shall be cancelled; and

WHEREAS, The Rules of Order Section 4.2.1 also states that during holiday periods, the application of specific days of the week described in the rules shall be revised by the Clerk of the Board as necessary for the efficient conduct of the legislative process; and

WHEREAS, The Rules of Order Section 4.2 also states the Board shall not meet during the week after Thanksgiving, nor between December 24 and December 31; and

WHEREAS, Similar to other sitting legislative bodies in the United States, the Board has established recess periods during the spring, summer and winter which Members of the Board may plan to be away, without missing any Board or Committee meetings or other important public business, and without causing difficulties in achieving a quorum; and

WHEREAS, The Board is constrained by certain administrative, electoral and legislative deadlines and may call a special meeting pursuant to San Francisco Administrative Code, Section 2.8 and Board Rule 4.3 at any time to conduct the City's business; now, therefore, be it

MOVED, Pursuant to Board Rules 4.2, and 4.2.1 the following Board meetings, are cancelled due to the Board of Supervisors observed holidays: January 3 (New Year's Day holiday); January 17 (Martin Luther King Jr. Day); February 21 (President's Day); May 30 (Memorial Day); July 4 (4th of July); October 10 (Columbus Day); November 7 (Veteran's Day); and, be it
