WHEREAS, The San Francisco Marina Small Craft Harbor ("the Marina") is a 12 recreational marina owned by the City and County of San Francisco and operated by the San 13 Francisco Recreation and Park Department ("RPD"), located at Marina Green Drive and Scott 14 Street on San Francisco's northern shoreline; and 15

WHEREAS, The State of California Department of Parks and Recreation, Division of 16 Boating and Waterways (DBW) is a State department responsible for recreational boating-17 related matters, including public access, safety and education, marine law enforcement, and 18 19 consumer and environmental protection; and

WHEREAS, DBW operates the Surrendered and Abandoned Vessel Exchange (SAVE) 20 21 grant program which provides funds to local public agencies in California to remove, store, and dispose of abandoned, wrecked, or dismantled vessels or any other partially submerged 22 objects which pose a substantial hazard to navigation; and 23

24 WHEREAS, In 2017, RPD will be starting a renovation of the Marina's East Basin, and all bertholders will be mandated to leave their berths to accommodate this project: and 25

WHEREAS, RPD anticipates that 10% to 15% of these bertholders will abandon their vessels when asked to leave the East Basin prior to the renovation; and

WHEREAS, RPD applied for, and DBW has awarded, up to \$100,600.00 in funds from the SAVE grant program, to help abate costs of hauling out and disposing of these potential future abandoned vessels; and

WHEREAS, On September 15, 2016, the Recreation and Park Commission recommended, by Resolution No. 1609-003, that the Board of Supervisors authorize the Recreation and Park Department to accept and expend a cash grant of up to \$100,600 from the SAVE grant program to abate costs for hauling out and disposal of potential future abandoned vessels in the Marina East Basin; and

WHEREAS, The Grant Agreement is subject to this Board's approval, and is on file with the Clerk of the Board of Supervisors in File No. 161243, which is hereby declared to be a part of this Resolution as if set forth fully herein; and

Proposed Grant Project Summary: The Surrendered and Abandoned Vessel Exchange (SAVE) grant program is designed to remove, reduce and prevent abandoned recreational vessels and various marine debris. The San Francisco Marina Small Craft Harbor anticipates renovating the East Basin of the Marina beginning in 2017. Due to soil contamination, all bertholders in the East Basin will be mandated to leave the Marina prior to the start of construction, throughout the entire duration of the renovation. We predict that 10% - 15% of the bertholders will abandon their boats when we ask them to leave the East Basin prior to the renovation, and the SAVE grant will help abate the cost of hauling out and disposing of abandoned boats

#### EXHIBIT B

#### Surrendered and Abandoned Vessels Exchange (SAVE) Grant Program

#### NEEDS AND OBJECTIVES OF DBW

1.

- a. Pursuant to its authority under Harbors and Navigation Code section 525, the Division of Boating and Waterways (DBW) wishes to contract with Grantee for the removal and disposal of abandoned, wrecked or dismantled vessels, or parts thereof, or any other partially submerged objects (hereinafter "eligible water hazards") which pose a substantial hazard to navigation within Grantee's jurisdiction as listed on the Questionnaire, found in Exhibit A.
- b. Pursuant to its authority under Harbors and Navigation Code Section 525, the Division of Boating and Waterways (DBW) wishes to contract with Grantee for the removal and disposal of surrendered vessels, or parts thereof, which are in danger of being abandoned and has a likelihood of causing environmental degradation or becoming a hazard to navigation within Grantee's jurisdiction as specified according to the Grantee's Work Plan, found in Exhibit A.

#### 2. WATER HAZARDS ELIGIBLE FOR REMOVAL AND DISPOSAL

The funds provided under this Agreement shall be used for the combined purposes of Surrendered and Abandoned Vessels Exchange (SAVE) as follows:

a. Abatement, removal, storage and/or disposal of eligible water hazards. For purposes of this Agreement, "abandoned" is defined in Harbors and Navigation Code section 522(a):

"Any hulk, derelict, wreck, or parts of any ship, vessel, or other watercraft sunk, beached, or allowed to remain in an unseaworthy or dilapidated condition upon publicly owned submerged lands, salt marsh, or tidelands within the corporate limits of any municipal corporation or other public corporation or entity having jurisdiction or control over those lands, without its consent expressed by resolution of its legislative body, for a period longer than 30 days without a watchman or other person being maintained upon or near and in charge of the property, is abandoned property".

Harbors and Navigation Code, Section 525 (1)(A):

"...the Abandoned Watercraft Abatement Fund, which is hereby created as a special fund. Moneys in the fund shall be used exclusively, upon appropriation by the Legislature, for grants to be awarded by the department to local agencies for the abatement, removal, storage, and disposal as public nuisances of any abandoned property as described in Section 522 or for the disposal of surrendered vessels as defined in Section 526.1, wrecked or dismantled vessels, or parts thereof, or any other partially submerged objects that pose a substantial hazard to navigation, from navigable waterways or adjacent public property or private property with the landowner's consent.

- b. The funds provided under this Agreement shall not be utilized for abatement, removal, storage, or disposal of commercial vessels. Commercial vessels include those vessels for which the most recent registration or documentation was commercial, even though that registration or documentation may have lapsed.
- c. If Grantee is reimbursed for the costs related to the abatement, removal, storage, and/or disposal of an eligible water hazard by the registered or legal owner or other

person or entity known to have an interest in the water hazard, then the water hazard shall no longer be eligible for funding under this Agreement. Grantee shall notify DBW in writing of such reimbursement and shall return all funds disbursed by DBW to Grantee with respect to such water hazard immediately.

- d. **Abatement, removal, storage and disposal of eligible surrendered vessels**. For purposes of this Agreement, "surrendered" is defined in Harbors and Navigation Code section 526.1(a):
- e. "'surrendered vessel' means a recreational vessel that the verified titleholder has willingly surrendered to a willing agency under both of the following conditions:
  - (1) The public agency has determined in its sole discretion that the vessel is in danger of being abandoned, and therefore has a likelihood of causing environmental degradation or becoming a hazard to navigation.
  - (2) The decision to accept a vessel is based solely on the potential of the vessel to likely be abandoned and cause environmental degradation or become a hazard to navigation."
- f. The funds provided under this Agreement shall not be utilized for surrender, abatement, removal, storage, or disposal of commercial vessels. Commercial vessels include those vessels for which the most recent registration or documentation was commercial, even though that registration or documentation may have lapsed.
- g. If Grantee is reimbursed for the costs related to the removal, storage, and/or disposal of a surrendered vessel by the registered or legal owner or other person or entity known to have an interest in the vessel, then the vessel shall no longer be eligible for funding under this Agreement. Grantee shall notify DBW in writing of such reimbursement and shall return all funds disbursed by DBW to Grantee with respect to such vessel immediately.

#### 3. RIGHT OF INSPECTION

Grantee shall allow DBW and other state agency representatives, at any reasonable time, to inspect any site where Grantee or its subcontractors are performing work under this Agreement.

#### 4. ANNUAL MEETING

Grantee's representative or alternate shall participate in an annual one-day video or phone conference conducted by DBW during the term of this agreement. Should the Grantee or representative be unable to attend the meeting and cannot provide a substitute from the agency, the Grantee must forward a letter to DBW stating the reason why they cannot attend. DBW must grant approval in writing in order for the Grantee not to be in breach of this Agreement for failure to attend.

#### 5. ACTIVITY/NON ACTIVITY: REPORTING REQUIREMENTS

- a. Grantee shall provide quarterly reports to DBW describing the status of existing issues known, pending, or in progress.
- b. Lack of quarterly reporting and/or removal activity within any twelve month period during the term of this agreement is subject to possible revocation of grant.

#### 6. OVERLAPPING ANNUAL GRANT AWARDS

A minimum of fifty percent (50%) of an existing SAVE grant must be utilized and reported for reimbursement to DBW by the new grant application deadline to qualify for a new fiscal year grant. Only one overlapping grant per fiscal year will be allowed.

### 7. HAZARDOUS MATERIALS

Grantee shall be responsible for securing any necessary or prudent studies, permits, or authorizations associated with treatment, removal, storage, or any other handling of hazardous substances including, but not limited to, toxic waste, petroleum waste, asbestos, and similar substances, prior to the removal of any vessel and water hazard pursuant to this Agreement.

Grantee shall be responsible for the proper and lawful handling, abatement, removal, storage, and/or disposal of any hazardous substances encountered in the execution of this Agreement.

#### 8. TITLES AND LIENS

- a. Abandoned vessels: Grantee shall comply with all relevant provisions of the Harbors and Navigation Code regarding notices, hearings and liens in the performance of this Agreement. Grantee (in conjunction with local law enforcement) shall conduct a title search for all vessels presumed to be abandoned, as provided by Harbors and Navigation Code section 526.
- b. **Surrendered vessels:** Grantee shall comply with all relevant provisions of Harbors and Navigation Code section 526.1 in the performance of this Agreement, requiring that a surrendered vessel be that of the "verified titleholder."

#### 9. MEDIA

Grantee agrees to acknowledge DBW's financial support whenever work funded by this Agreement is publicized in any news media, brochures, or other type of promotional material.

### 10. MEDIA MATERIALS RELEASE

Grantee agrees to irrevocably grant to California State Parks, Division of Boating and Waterways, its employees, officers, agents, and assigns (hereinafter referred to as "DBW"). the non-exclusive, royalty-free, perpetual and worldwide right and permission to use, reproduce, publish, copy, distribute, alter, license, adapt, and display the photographs, motion pictures, caption information, and/or written quotes (hereinafter referred to collectively as "Photographs"), that the Grantee has submitted to DBW for art, editorial, advertising, marketing, trade, broadcast, print, educational programs, or any other lawful purpose whatsoever, in any and all media. In connection with the foregoing license, the Grantee agrees not to use, reproduce, adapt, or display the Photographs, or allow others to do so, in a manner that tends to subject DBW or its AWAF, VTIP and/or SAVE programs to ridicule, disparagement, mockery, satire, or that could tarnish the image of the DBW's AWAF, VTIP, and/or SAVE programs. Grantee hereby releases and discharges DBW from any and all claims and demands arising out of or in connection with the use of the Photographs, including without limitations, any and all claims for libel, defamation, invasion of privacy, and/or publicity rights. DBW assumes no responsibility for lost or damaged Photographs or for the use of same. DBW may sell, assign, license, or transfer all rights granted to it hereunder.

Grantee also grants DBW and its licensees the unrestricted right to use and disclose its

name in connection with use of the Photographs. The Grantee understands that it will not be paid for any use or right granted herein.

The Grantee understands and agrees that the Photographs may be used in whole or in part, at any time. The license granted herein to DBW includes the right and permission to conduct or have conducted such alterations to the Photographs as DBW deems necessary. Grantee releases and discharges DBW and agrees to indemnify and hold DBW harmless from any liability by virtue of any blurring, distortion, alteration, optical illusion or use in composite form, loss or damage, whether intentional or otherwise, that may occur in the use of the Photographs. Prior to the removal of any abandoned vessel, eligible water hazard, or surrendered vessel, the Grantee shall obtain all necessary permits, authorizations, and documentation necessitated by any applicable provision of law.

#### 12. SECURING OF BIDS

Grantee shall comply with any applicable laws and regulations governing the competitive bidding process when awarding subcontracts to marine salvage companies under this Agreement.

#### 13. SUBCONTRACTORS

Grantee agrees that it shall guarantee and shall be responsible for ensuring that any and all of its contractors and subcontractors holds a valid business license and carries general commercial liability insurance coverage sufficient to fully insure against any and all risks of hazardous activities associated with the work to be performed under this Agreement; and Grantee agrees that if any of Grantee's contractors or subcontractors fail to fulfill any of these requirements, that Grantee itself carries general commercial liability insurance coverage sufficient to fully insure against any and all risks of hazardous activities associated with the work to be performed by the Grantee coverage sufficient to fully insure against any and all risks of hazardous activities associated with the work to be performed under this Agreement, whether performed by the Grantee, Grantee's contractor(s), or Grantee's subcontractor(s). Grantee shall provide DBW with a certificate of insurance from any contractor(s) and subcontractor(s) prior to the commencement of any work under this Agreement.

### 14. TRAFFIC CONTROL AND TRAFFIC SAFETY

The Grantee shall provide for adequate traffic control and safety measures at any site where Grantee and its subcontractors will perform any work under this Agreement.

#### 15. AIR OR WATER POLLUTION VIOLATION

Grantee warrants that it is not (1) in violation of any order or resolution not subject to review promulgated by the State Air Resources Board or an air pollution control district; (2) subject to any cease and desist order not subject to review issued pursuant to Water Code section 13301 for violation of waste discharge requirements or discharge prohibitions; or (3) finally determined to be in violation of provisions of federal law relating to air or water pollution.

### 16. ENTIRE AGREEMENT

This Agreement consists of the terms of this Agreement and all attachments, which are expressly incorporated herein. No amendment or variation of the terms of this Agreement shall be valid unless made in writing, signed by the parties and approved as required.

#### 17. APPROVAL OF AGREEMENT AND AMENDMENTS

This Agreement and any variation thereto is of no force or effect until signed by both parties and approved by the Department of General Services, if required. Commencement of performance prior to approval of this Agreement will be at the Grantee's own risk.

### 18. DISABLED VETERAN BUSINESS ENTERPRISE (DVBE) PARTICIPATION REQUIREMENT

There are no Disabled Veteran Business Enterprise participation requirements with this agreement.

### 19. AUTHORITY TO CONTRACT

Grantee must provide DBW with evidence of its authority to enter into this Agreement. Grantee may provide a delegation of contracting authority from its local governing body that by law has authority to contract. Alternatively, Grantee shall provide DBW with a resolution, order, motion, or ordinance of its local governing body that by law has authority to contract, authorizing execution of this Agreement.

#### 20. COMPLIANCE WITH LAW AND REGULATIONS

Grantee and its subcontractor(s) shall comply with all applicable laws and regulations of the State of California for all work to be performed under this Agreement. #### 21. INDEPENDENT CONTRACTOR

Grantee and its employees are independent contractors and shall not be considered officers or employees of DBW or agents of the State of California.

#### 22. INSURANCE REQUIREMENTS

The abatement, removal, storage, and /or disposal of vessels under this Agreement is a hazardous activity. Grantee therefore must maintain commercial general liability insurance in an amount and of a type acceptable to DBW and to the Department of General Services/ Office of Risk and Insurance Management (ORIM).

This Agreement is not assignable by the Grantee, either in whole or in part, without the consent of the State in the form of a formal written amendment.

#### 5. AUDIT:

Grantee agrees that the awarding department, the Department of General Services, the Bureau of State Audits, or their designated representative shall have the right to review and to copy any records and supporting documentation pertaining to the performance of this Agreement. Grantee agrees to maintain such records for possible audit for a minimum of three (3) years after final payment, unless a longer period of records retention is stipulated. Grantee agrees to allow the auditor(s) access to such records during normal business hours and to allow interviews of any employees who might reasonably have information related to such records. #### 1. Agency Type and Area of Responsibility (AOR)

The San Francisco Marina Small Craft Harbor is the oldest recreational marina operating in San Francisco, and perhaps the Greater Bay Area, the harbor has had vessels berthed in its original basin, now known as the West Harbor, since before the 1906 earthquake. The original marina was expanded in the mid-1960s and is now approximately 35 acres. The entire facility has 727 berths, including 15 end ties for guest berthing vessels up to 50 feet LOA, free pump out stations and a commercial fuel dock.

The San Francisco Marina Small Craft Harbor is managed by San Francisco Recreation and Park Department. We manage both East and West Basins of the Marina consist of 727 slips and we have hundreds of transients every year. San Francisco Marina also features a large and popular park, Marina Green, which is home to many events including Escape From Alcatraz and Fleet Week.

#### 2. Statement of Need

The San Francisco Marina is going to renovate the East Basin of the Marin in year 2017 and 2018. Due to the contamination of the soil, our plan is to ask all the bertholders to leave the Marina until the renovation is complete. We renovated the West Basin by section and most boats moved to the East basin temporarily during the West Basin renovation. We anticipate a 100% occupancy rate in the West Basin by 2016, therefore, we will not have temporary slips available for the East Basin bertholders during the East Basin renovation. We predict that 10% - 15% of the bertholders will abandon their boats when we asked bertholders to leave the East basin before the renovation.

There was one boat that was being abandoned at the San Francisco marina due to non-payment in 2015 and \$1,082.72 was being submitted for reimbursement. In April, 2016, we found a submerged engine in one of the slips in the East Basin of the Marina. We already scheduled vendor to remove and dispose the engine block and they will charge us \$4,200.00 for the service. Since Marina staff check the boats everyday and work closely with bertholders for berthing fees collection, we anticipated less abandoned boats in FY 15/16 than previous years.

The San Francisco Marina did not sign up for the Vessel Tum-In Program since we do not have room to store abandon boats and Marina staff already reached their capacity and we do not have the man power to participate in the Vessel Turn-In Program. Moreover, the East Basin renovation will take up a lot of staff time. However, the SF Marina will continue to support and promote the VTIP program and through our website and the keeping the VTIP information available in the Harbor Master's Office.

#### 1. Legal authority to remove abandoned vessels

The San Francisco Marina is governed by the San Francisco Marina Small Craft Harbor Rules and Regulations which was being approved and adopted by the Recreation and Parks Commission of San Francisco. Section 30B,C, and D stated the SF Marina's legal authority to handle and remove abandoned vessels.

#### Section 30 - VIOLATION OF RULES AND REGULATIONS

B. Except as otherwise provided herein, cancellation shall be governed by this Section 30. In the event of any breach of the Rules and Regulations by an owner, the Harbormaster shall have the right to terminate owner's berthing license in accordance with the following procedure:

1. If (a) the Harbormaster considers that the breach is a threat to health and/or safety, or (b) the breach is incapable of remedy, then the Harbormaster may terminate without prior notice. The Harbormaster will provide the owner prompt written notice of such termination.

2. Otherwise, the Harbormaster will first provide a written warning notice to the owner, specifying the breach and requiring owner to remedy such breach within seven (7) calendar days. If the owner fails to remedy the breach within seven (7) calendar days, then the Harbormaster may at any time thereafter issue a termination notice having immediate effect, and may also require the owner to remove his/her vessel from the Marina within five (5) business days, or within such longer period as the Harbormaster may specify in such notice.

C. If an owner fails to remove owner's vessel from the Marina after the issuance of a notice of termination, regardless of the reason for such termination, then the Harbormaster may:

1. Charge the owner at a published daily/visitor fee rate for keeping a vessel at the Marina; and/or

2. Remove the vessel and charge owner for this move and for any subsequent storage or other costs necessarily incurred; and/or

3. Serve the owner with a three (3) month notice of Harbormaster's intention to dispose of the vessel at auction.

D. Disposal shall be in accordance with the following procedure:

1. If an owner has failed to respond to the disposal notice by paying all the amounts owed to the marina and, if applicable, by removing the vessel from the Marina, then the Harbormaster may sell the vessel at public auction at any time following the expiration of the three (3) month notice period.

2. Within one (1) month of serving a disposal notice, the Harbormaster shall advertise his/her intention to dispose of the vessel at auction in two regional or national daily newspapers and shall fix a copy of the notice to the superstructure of the vessel.

3. The Harbormaster shall be entitled to deduct from the proceeds of the auction any outstanding debt and any costs, including reasonable management costs, necessarily incurred by the Marina or the Harbormaster.

#### 2. Agency Experience

Most of the boats that were being abandoned at the San Francisco Marina was due to failure to pay berthing fees and people ended up abandoning their boats in the Marina. In year 2012 to 2013, 15 boats were being abandoned at the San Francisco Marina due to the West Basin renovation. Some people were reluctant to move their boats out of the Marina for renovation and they just abandoned their boats. We anticipated to have 10% -15% of bertholders abandoning their boats when we renovate the East Basin of the Marina.

#### 3. Adjudication Process

The San Francisco Marina Small Craft Harbor's Marina follows the below procedure in handling abandoned vessels:

- 1. Review quarterly collection report from the Total Marina Package for all delinquent accounts. Send out 7-day warning letter.
- 2. If bertholder is delinquent over within 50 calendar days, a cancellation letter will be sent to bertholder.
- 3. The Marina makes and documents all attempts to contact the vessel owner for delinquent dockage fee payment. If the owner's contact information is on file or found through the DMV or USCG, the Marina staff sends certified letters warning of actions to be taken 90 days in advance of any auction.
- 4. Notify Marine Line Service and provide information of the lien boat.
- 5. Fax completed lien request form to Marine Lien Service for processing
- 6. DMV will send authorization to conduct a lien sale or the owner may file an opposition to the lien. If opposed, the City will then have to go to the Small Claims Court to get a judgment.
- 7. The Marina Lien Service will then contact Marina staff to schedule a date for public lien sale. Marina lien service will advertise the sale in two regional or national daily newspapers and affixes a copy of the notice to the superstructure of the vessel.
- 8. On the day of the auction, the Marina Lien Service will conduct the auction. The vessels should be ready for inspection one hour prior to the auction. The auction price should start at the debt owed if the vessel is worth the amount. IF the selling price is more than debt, include dockage fees, all labor to sell boat and if boat had to be pumped out. The remaining money is sent to DMV. If a sale occurs, the purchaser must fill out the promissory Note with a 30% of the purchase price deposit. The balance due in 10 days after the sale to redeem the vessel by paying all amounts owed. After the 10-day redemption period, the new owner has 5 days to remove the vessel from the Marina.

#### Vessel Disposal

Since most, if not all, of the abandoned vessels are worth nothing and are not sold at auction, the Marina ends up with ownership of the vessel. The Marina then contracts with a salvage yard to tow the vessel away and dispose of it, here's the procedure:

- After the auction, the boats that are not sold are property of the San Francisco Marina Small Craft Harbor and will be kept for 10 days.
- After the 10-day period, the boat will schedule to be towed and disposed
- · Marina staff will get quote from salvage service, and the quote shall include hazardous waste.
- Marina staff sends paperwork and documents to salvage service and takes pictures of the boat before the salvage service tows the boat away.
- After the disposal is complete, the salvage service will fill out all the paperwork and send a copy to the san Francisco Marina.
- Marina staff will send the outstanding charges related to the disposal to Bureau of Delinquent Revenue for collection.

Lien vessels are the property of either the Marina or successful bidders ten days after the auction dates. Boat owners have up to and including the 10-day to satisfy the lien or remove all personal properties. Anything related of boating stays with the vessels.

If vessels are sold, the names of buyers go on the certification lien sale form, and the Marina keeps copies as a release of liability.

#### 4. Agency prevention efforts of abandoned vessels

The San Francisco Marina staff walk the dock every to check if there is any sinking boats in the Marina. Staff does a thorough dock check for the East and West Basin every week and checks if there is any compliancy issue like boats in bad shape, leaking, taking on water or other issues. Marina office staff will notify bertholders with such issues and the Marina Associate manager would follow up with bertholders with 7-day warning letters if issued were not addressed properly. Marina Office staff generates a collection report every quarter and contacts bertholders with delinquent accounts through phone calls, email, and mail. Marina staff would work with bertholders like phase payments and if they really could not pay the berthing fees, Marina staff would always refer bertholders to the VTIP program instead of abandoning their

#### boats.

The San Francisco has an established internal process outlining procedures to prevent, mitigate and process abandoned vessels (please see attachment on next page), but the bylaws, regulations or ordinances that help prevent or mitigate abandoned vessels is not in place. Such bylaws, regulations, and ordinances involve changing the San Francisco Marina Rules and Regulations. The San Francisco Marina Rules and Regulations were being updated in year 2012 and our plan is to update it again in 3-5 years.

As mentioned before, marina staff walks the docks and does thorough dock checks for both basins every week. Marina staff will always report to the Marina office staff when boats take on water, replacing lines for boats, pumping out water from boats, and etc. Marina office staff will notify bertholder and keep record on file. When similar incidents happen again and/or bertholder does not address the issues properly, such boat is deemed at-risk and a 7-day warning letter will be issued to the bertholder. The San Francisco Marina just started a ?Dock Captain? program. The intention is to have a dock captain representing his/her own to improve communication between the Marina management/staff and the bertholders. It is a good way to work bertholder to maintain their boats and prevent them from abandoning their vessels.

Yes, bertholders are required to submit current boat registration or Coast Guard documentation when they first sign up for slips. Bertholders are required to renew their berthing license agreements every year in July and current boat registration or Coast Guard documentation and current insurance certificates are required to be turn in to the Marina office along with berthing license renewal form.
