WHEREAS, Mainland Market Co. is seeking the transfer of a Type 20 off-sale beer and wine license dba Mainland Market Co. located at 5601 Geary Boulevard (District 1); and

WHEREAS, The Planning Department has verified that the area is properly zoned and recommends approval; and

WHEREAS, The Police Department has filed one (1) protests with the Department of Alcoholic Beverage Control under California Business and Professions Code, Section 24013, and recommends that the Department of Alcoholic Beverage Control issue the liquor license with conditions; and

WHEREAS, The conditions recommended by the Police Department are the following: 1) Sales of alcoholic beverages shall be permitted between the hours of 7:00 a.m. to 10:00 p.m. each day of the week; 2) no beer or malt beverages shall be sold in guantities of less than manufacturer pre-packaged six packs per sale with the exception of wine-coolers, beer coolers which must be sold in manufacturer pre-packaged multiunit quantities of four (4) or more; 3) no wine shall be sold with an alcoholic content of


greater than 15% by volume except for "Dinner Wines" which have been aged two years or more and maintained in corked bottles; and 4) loitering (defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee; now, therefore, be it
