

1 [Accept and Expend Grant - Regents of the University of California - GH13-1328, HQ,
2 Technical Assistance to Countries Supported by the United States President's Emergency
3 Plan for AIDS Relief and Global - \$132,973]

4 **Resolution retroactively authorizing the Department of Public Health to accept and**
5 **expend a grant in the amount of \$132,973 from The Regents of the University of**
6 **California to participate in a program entitled GH13-1328, HQ, Technical Assistance to**
7 **Countries Supported by the United States President's Emergency Plan for AIDS Relief**
8 **and Global for the period of April 1, 2016, through March 31, 2017.**

10 WHEREAS, The Regents of the University of California is the recipient of a grant award
11 from Centers for Disease Control and Prevention (CDC) supporting GH13-1328, HQ,
12 Technical Assistance to Countries Supported by the United States President's Emergency
13 Plan for AIDS Relief (PEPFAR) and Global grant; and

14 WHEREAS, With a portion of these funds, The Regents of the University of California
15 has subcontracted with Department of Public Health (DPH) in the amount of \$132,973 for the
16 period of April 1, 2016, through March 31, 2017; and

17 WHEREAS, As a condition of receiving the grant funds, The Regents of the University
18 of California requires the City to enter into an agreement (Agreement), a copy of which is on
19 file with the Clerk of the Board of Supervisors in File No. 161075; which is hereby declared to
20 be a part of this Resolution as if set forth fully herein; and

21 WHEREAS, The purpose of this project will provide technical assistance and capacity
22 building for in-country partners on cascade analysis and HIV case-based surveillance
23 activities; and

24 WHEREAS, An Annual Salary Ordinance amendment is not required as the grant
25 partially reimburses DPH for four existing positions, one Manager I (Job Class No. 0922) at

1 .10 FTE, one Manager I (Job Class No. 0922) at .10 FTE, one Senior Physician Specialist
2 (Job Class No. 2232) at .20 FTE and one Supervising Physician Specialist (Job Class No.
3 2233) at .15 FTE for the period of April 1, 2016, through March 31, 2017; and

4 WHEREAS, A request for retroactive approval is being sought because DPH did not
5 receive notification of the award until August 20, 2016, for a project start date of April 1, 2016;
6 and

7 WHEREAS, The budget includes a provision for indirect costs in the amount of
8 \$14,247; now, therefore, be it

9 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant
10 in the amount of \$132,973 from The Regents of the University of California; and, be it

11 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
12 expend the grant funds pursuant to San Francisco Administrative Code, Section 10.170-1;
13 and, be it

14 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
15 Agreement on behalf of the City.






