3 **Resolution authorizing the Fire Department to accept and expend a donation of \$72,400**  
4 **to purchase firefighting equipment, pursuant to the terms of the administration of the**  
5 **Pastor Revocable Trust and the estate of Russell Pastor.**

7 WHEREAS, The San Francisco Fire Department was contacted by the Law Offices of  
8 Corey & Corey; and

9 WHEREAS, The San Francisco Fire Department learned that it was listed as a  
10 beneficiary of the Pastor Revocable Trust and the estate of Russell Pastor and pursuant to  
11 the trust was to receive a share of the estate; and

12 WHEREAS, The San Francisco Fire Department received two checks totaling the  
13 amount of \$72,400 from the Law Offices of Corey & Corey as a distribution of the estate; and

14 WHEREAS, Upon acceptance of these funds, the San Francisco Fire Department will  
15 use the funds to purchase firefighting equipment per the terms of the trust; and

16 WHEREAS, At its regular meeting on Wednesday, February 10th, 2016, the Fire  
17 Commission voted to recommend that the Board of Supervisors approve the gift and  
18 authorize the Chief of the Fire Department to accept the donation to the Department; and

19 WHEREAS, The Fire Commission Resolution is on file with the Clerk of the Board of  
20 Supervisors in File No. 161167, which is hereby declared to be a part of this resolution as if  
21 set forth fully herein; now, therefore, be it

22 **RESOLVED**, That the Board of Supervisors approves the donation and authorizes the  
23 Chief of the Fire Department to accept and expend \$72,400 pursuant to the terms of the  
24 administration of the Pastor Revocable Trust and the estate of Russell Pastor.




