ORDINANCE NO.

[Settlement of Lawsuit - Bradley Bishop - \$750,000]

Ordinance authorizing settlement of the lawsuit filed by Bradley Bishop against the City and County of San Francisco for \$750,000; the lawsuit was filed on February 9, 2015, in San Francisco Superior Court, Case No. CGC-15-544028; entitled <u>Bradley Bishop v. City and County of San Francisco, et al.</u>; the lawsuit involves a medical malpractice claim; other material terms of the settlement are: City and County of San Francisco to waive offset of \$13,891.80 for unpaid services, and Regents of the University of California to pay \$1,750,000.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Bradley Bishop v. City and County of San Francisco, et al.</u>, San Francisco Superior Court, Case No. CGC-15-544028 by the payment of \$750,000 and waiver of the \$13,891.80 offset for unpaid services. Regents of University of California will also pay \$1,750,000 to the Plaintiff. The lawsuit involves a medical malpractice claim.

Section 2. The above-named action was filed in San Francisco Superior Court on February 9, 2015, and the following parties were named in the lawsuit: Plaintiff: Bradley Bishop; Defendants: City and County of San Francisco, Regents of the University of California, N. Young, MD, Rachel MacFarland, RN, Michael Ansfield, MD, Nichael Terry, MD, Patrick Williams, RN.
