Resolution approving the settlement of unlitigated claim filed by Mignon Dunbar against the City and County of San Francisco for \$70,000; including two charges that were filed with the Department of Fair Employment and Housing, one on November 24, 2014, the other on February 4, 2015; the claim involves an employment dispute; additional material terms of the settlement are that Dunbar resigns employment effective August 19, 2016, and that she agrees not to seek or accept future employment

WHEREAS, Mignon Dunbar filed charges with the Department of Fair Employment and Housing (DFEH) on November 24, 2014, and February 4, 2015, against the City and County of San Francisco; and

WHEREAS, The claim involves an alleged employment dispute; and

WHEREAS, The Police Department (SFPD) has recommended settlement of the claim by payment of \$70,000 and resignation of Dunbar effective August 19, 2016, and agreement by Dunbar not to seek or accept future employment with the SFPD; now, therefore, be it

RESOLVED, That pursuant to Administrative Code, Section 10.22, the Board of Supervisors hereby authorizes the City Attorney to settle and compromise the claim by payment of \$70,000 and agreement by Dunbar to resign and not seek or accept future employment with the SFPD.
