3 **Ordinance authorizing settlement of the lawsuit filed by 501 Folsom Street, LLC,**
4 **against the City and County of San Francisco for \$40,000; the lawsuit was filed on**
5 **November 27, 2013, in San Francisco Superior Court, Case No. CGC-13-535767; entitled**
6 **501 Folsom Street LLC v. City and County of San Francisco; the lawsuit involves**
7 **alleged property damage arising from flooding.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled 501 Folsom Street LLC v. City and
12 County of San Francisco, San Francisco Superior Court, Case No. CGC-13-535767 by the
13 payment of \$40,000. The lawsuit involves alleged property damage arising from flooding.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 November 27, 2013, and the following parties were named in the lawsuit: Plaintiff: 501
16 Folsom Street LLC; Defendant: City and County of San Francisco.


