Ordinance authorizing settlement of the lawsuit filed by 501 Folsom Street, LLC, against the City and County of San Francisco for \$40,000; the lawsuit was filed on November 27, 2013, in San Francisco Superior Court, Case No. CGC-13-535767; entitled <u>501 Folsom Street LLC v. City and County of San Francisco</u>; the lawsuit involves alleged property damage arising from flooding.
