Traci Watson, seat 6, succeeding Anakh Sul Rama, term expired November 23, 2016, must be selected from a list of candidates that are nominated by non-profit agencies that provide advocacy or organizing services to homeless people, for the unexpired portion of a two-year term ending November 23, 2018.
