City and County of San Francisco</u>, et al., San Francisco Superior Court, Case No. CGC-15-544028 by the payment of \$750,000 and waiver of the \$13,891.80 offset for unpaid services. Regents of University of California will also pay \$1,750,000 to the Plaintiff. The lawsuit involves a medical malpractice claim.
