3 **Ordinance authorizing settlement of the lawsuit filed by The Regents of the University**
4 **of California against the City and County of San Francisco for \$473,530.02; the lawsuit**
5 **was filed on September 22, 2015, in San Francisco Superior Court, Case No. CGC-15-**
6 **548090; entitled The Regents of the University of California v. City and County of San**
7 **Francisco; the lawsuit involves a refund for overbilling; other material terms of the**
8 **settlement are that the refund will be in the form of a credit against future charges for**
9 **water service.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby
13 authorizes the City Attorney to settle the action entitled The Regents of the University of
14 California v. City and County of San Francisco, San Francisco Superior Court, Case No.
15 CGC-15-548090 by the payment of \$473,530.02 and other material terms of the settlement
16 are that the refund will be in the form of a credit against future charges for water service.

17 Section 2. The above-named action was filed in San Francisco Superior Court on
18 September 22, 2015, and the following parties were named in the lawsuit: Plaintiff: The
19 Regents of the University of California, a California public corporation, Defendant: City and
20 County of San Francisco.




