

ALU Recommendation: Approval with the following conditions:

- 1. Sales, service and consumption of alcoholic beverages shall be permitted between the hours of 10:00 a.m. and 2 a.m. daily.
- 2. No noise shall be audible beyond the area under the control of the licensee(s) as depicted on ABC-257 dated 10/21/16.
- 3. The sales of alcoholic beverages for off- sale consumption is strictly prohibited
- 4. Alcoholic beverages shall only be served and poured by premises employees. Patrons are prohibited from serving themselves alcoholic beverages in the premises.
- 5. Loitering (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee as depicted on ABC-257 dated 10/21/16.
- \* It should be noted that the Applicant agrees with all the above conditions.


