

1 [Contract Amendment - ComputerLand of Silicon Valley - Technology Marketplace,  
2 Tier 1A - \$58,000,000]

3 **Resolution authorizing the Office of Contract Administration to enter into the Third**  
4 **Amendment to the contract agreement between the City and County of San Francisco**  
5 **and ComputerLand of Silicon Valley, a Technology Marketplace, Tier 1A Generalist**  
6 **contractor, to increase the contract limit from \$44,000,000 to \$58,000,000 for the period**  
7 **of October 1, 2014, through September 30, 2018.**

9 WHEREAS, The Office of Contract Administration, by competitive bidding, developed  
10 the Technology Marketplace procurement method for the purchase of products and services  
11 related to Information Technology; and

12 WHEREAS, ComputerLand of Silicon Valley is one of the six vendors who is part of  
13 the Technology Marketplace, Tier1A Generalists; and

14 WHEREAS, The original contract with ComputerLand of Silicon Valley dated  
15 October 1, 2014 has a term of three years through September 30, 2017, with options to  
16 extend the term through September 30, 2019, and has an original contract amount of  
17 \$12,000,000; and

18 WHEREAS, The Board of Supervisors approved the original contract on  
19 October 1, 2014, by Resolution No. 362-14; and

20 WHEREAS, The Board of Supervisors approved the First Amendment to the contract  
21 on July 14, 2015, by Resolution No. 260-15 to increase the contract amount from  
22 \$12,000,000 to \$32,000,000; and

23 WHEREAS, The Board of Supervisors approved the Second Amendment to the  
24 contract on June 14, 2016, by Resolution No. 237-16 to increase the contract amount from  
25 \$32,000,000 to \$44,000,000; and

1           WHEREAS, The Office of Contract Administration estimates that the money  
2 projected to be spent with ComputerLand of Silicon Valley could reach the contract's limit in  
3 the reasonably near future; and

4           WHEREAS, Charter, Section 9.118(b) "Contract and Lease Limitations," requires the  
5 Board of Supervisors to approve any contract estimated to exceed \$10,000,000 in  
6 expenditures or amendments exceeding \$500,000 to such contracts; now, therefore, be it

7           RESOLVED, That the Board of Supervisors authorizes the Purchaser and the  
8 Director of the Office of Contract Administration to enter into the Third Amendment to the  
9 contract with ComputerLand of Silicon Valley in substantially the form attached to increase  
10 the contract limit from \$44,000,000 to \$58,000,000; and, be it

11           FURTHER RESOLVED, That within thirty (30) days of the Third Amendment being fully  
12 executed by all parties, the Office of Contract Administration shall provide the final Third  
13 Amendment to the Clerk of the Board for inclusion into the official file.
