The City and County of San Francisco (CCSF) is the steward of the Bay Area's homeland security grant funds and through our leadership and collaborative approach, I believe we have made the San Francisco Bay Area a more prepared and resilient community. The 12 counties that make up the San Francisco Bay Area Urban Area Security Initiative (UASI) region have entrusted the fiscal management and oversight of these funds to CCSF as fiscal agent not only for our leadership and commitment to collaboration, but also because we have the capability and capacity to manage the complex accounting processes and grant compliance requirements associated with the numerous grants the Bay Area receives from the State of California and U.S. Department of Homeland Security. It also is practical for us to be the fiscal agent because CCSF receives the highest allocation of the grant funds because we have the highest risk. We also receive five percent of the grant to fund the costs associated with its management.

As part of our responsibility to manage these funds, we must provide the State of California Office of Emergency Services a CCSF Governing Body Resolution to Apply for 2017 Homeland Security Grants by February 17, 2017. These funds are used throughout the Bay Area for personnel, programs, projects, and equipment dedicated to making our communities prepared and resilient. In San Francisco we invest our allocation in the following ways:

• Staffing: 39 city employees responsible for planning for, responding to, and recovering from emergencies. These are the people that help find care and shelter for residents displaced by fire and floods, manage incoming resources following a disaster, and send alerts and warnings to the public.

- Emergency Planning: Development of emergency plans for all hazards including earthquakes, tsunamis, public health emergencies, extreme weather, and man-made disasters. These plans are required in order to receive state and federal reimbursements following a declared emergency and must be maintained and updated.
- **Training and Exercise:** Investment in this area allows us to practice our plans and how we work together during an emergency. Examples include a Community Point of Distribution (C-POD) exercise conducted last year where we tested our ability to deliver and distribute life sustaining supplies to the public following catastrophic earthquake.
- **Community Preparedness:** San Francisco's Neighborhood Emergency Response Teams (NERT) and nationally recognized SF72 personal preparedness program are supported by homeland security and emergency preparedness grants. The NERT program provides free training to residents so they can take care of themselves, their family, and their community during an emergency. Last year, more than 10,000 people used SF72 as resource to develop their personal emergency plan.

As you know, this resolution was presented to the Budget and Finance Committee last Wednesday and it was voted to be continued during the next meeting taking place Thursday, February 2, 2017 due to public concerns regarding Alameda County's first responder and emergency management exercise Urban Shield. You heard from a number of concerned individuals requesting CCSF exclude funding Urban Shield with homeland security grants. As you may know earlier this month the Alameda County Board of Supervisors conducted a hearing to consider these same public concerns while deciding whether to continue the agreement to manage the Bay Area UASI training and exercise program, which includes Urban Shield. Over the course of many hours, the Board intently listened to each public commenter and ultimately voted unanimously to continue the agreement. The Alameda Board also voted to create a task force comprised of representatives from various public and community organizations (including two members of the Stop Urban Shield Coalition) to study the design and execution of Urban Shield. This fall, the task force will present to the Alameda Board of Supervisors its recommendations to continue or discontinue Urban Shield in 2018.

I look forward to hearing the recommendations of this task force and in the meantime I urge you to approve the governing body resolution to allow us to apply for these critical emergency preparedness and homeland security grants.

Dear President Breed:

I am writing to ask for the opportunity to meet with you in advance of the February 14, 2017 Board of Supervisors Meeting. It is critically important that San Francisco votes to approve a Governing Body Resolution so that we may receive federal homeland security and emergency preparedness grant funding.

The City is the fiscal agent of the Bay Area's homeland security grant funds. We have made the San Francisco Bay Area a more prepared and resilient community through our leadership and collaborative approach. The 12 counties and three cities (Oakland, San Francisco, and San Jose) that make up the San Francisco Bay Area Urban Areas Security Initiative (UASI) region have entrusted San Francisco with the fiscal management and oversight of the federal UASI Grant, which provides approximately \$22 million to the region annually. The City also receives approximately \$1.2 million from the State Homeland Security Grant, the Emergency Management Performance Grant, and the Local Government Oil Spill Contingency Plan Grant combined.

We are required to provide the State of California Governor's Office of Emergency Services and the California Department of Fish and Game Office of Spill Prevention and Response a Governing Body Resolution to Apply for 2017 Homeland Security and Emergency Preparedness Grants, which includes the UASI Grant, the State Homeland Security Grant, the Emergency Management Performance Grant, and the Local Government Oil Spill Contingency Plan Grant. These funds are used throughout San Francisco for personnel, programs, projects, and equipment dedicated to making our communities better prepared and more resilient. Without this Resolution, we will not be able to apply for 2017 homeland security and emergency preparedness grants.

Last week this Governing Body Resolution was heard at the Budget and Finance Committee with much discussion and deliberation about Alameda County's first responder and emergency management training exercise called Urban Shield. The discussion also included a review of how San Francisco uses its allocation of these grants, which predominately goes to 39 personnel salaries. With amendments, the Resolution was voted to go to the full Board of Supervisors without recommendation.

We would like to meet with you before the upcoming Board of Supervisors meeting to share how San Francisco invests its allocation of the grants; review the 39 City grant-funded personnel positions; explain our role as fiscal agent and how we manage the grants on behalf of the region; and discuss the Urban Shield exercise and the community concerns regarding this first responder and emergency management training event.

Urban Shield is an emergency management exercise that provides training to Bay Area first responders. Urban Shield engages thousands of law enforcement, fire, emergency medical, and emergency management personnel and features real-life scenarios to test preparedness plans and response capabilities to hazards such as mass shootings, terrorist and cyber-attacks, infrastructure collapse, and natural disasters.

You have likely heard from a number of concerned individuals requesting that the City exclude funding the Urban Shield emergency management training exercise with homeland security grants. We stand with members of the community in our commitment to civil rights, community empowerment, and strong relations between law enforcement and the community based on mutual trust. We believe the following recent developments support balancing the need for first responder and emergency management training with community concerns:

- Alameda County Board of Supervisors: On January 10, 2017 the Alameda County Board of Supervisors conducted a hearing to consider public concerns while deciding whether to continue the agreement to manage the Bay Area UASI training and exercise program, which includes the Urban Shield emergency management training exercise. Over the course of many hours, the Board intently listened to each public commenter and ultimately voted unanimously to continue the agreement.
- Oversight Task Force: The Alameda County Board of Supervisors also voted to create a task force comprised of representatives from various public and community organizations (including two members of the Stop Urban Shield coalition) to study the design and execution of the 2017 Urban Shield emergency management training exercise. This fall the task force will present to the Alameda County Board of Supervisors its recommendations to continue or discontinue the exercise training in 2018. [Please note, I have requested to participate on this task force.]
- *New Focus and Clearer Standards:* The 2017 Urban Shield emergency management training exercise will have a greater focus on medical and community emergency preparedness (e.g., Community Emergency Response Teams (CERT) and Neighborhood Emergency Response Teams (NERT)). Alameda County also established a clear list of standards prohibiting any elements of training that could be construed as racial profiling and surveillance.
- *Militarized Equipment:* "Militarized" or "weapons-grade equipment" are explicitly prohibited by federal grant guidelines. San Francisco's role as fiscal agent includes ensuring compliance to these and many other requirements.

Thank you in advance for considering the aforementioned points and I look forward to discussing this Resolution allowing the City to apply for these critical emergency preparedness and homeland security grants. I also welcome the opportunity to discuss how the Department of Emergency Management can be of service to you and your community as we plan, train, and prepare the City for emergencies. My staff will contact your legislative aides to find a time to meet.

This letter represents my support for the annual Urban Shield and the Yellow Command Exercise Events hosted by the Alameda County Sheriff's Office. These annual training exercises provide significant benefits for my Special Weapons and Tactics (SWAT) Team and my Emergency Operations Center (EOC) Staff by allowing them to test their skills and enhance their ability to respond and coordinate with other Operational Area Public Safety Agencies in our region and the State of California.

The Contra Costa County Office of the Sheriff's SWAT team has participated in the annual Urban Shield training exercise since its inception in 2007. Each year, Urban Shield has presented our tactical team with the opportunity to assess and evaluate our own tactics and readiness by going through multiple, near-real life scenarios based on actual critical incidents such as the Boston Marathon bombing, the San Bernardino and Paris mass shootings, the Nice and Berlin truck attacks, and numerous multi-casualty school shootings. It is the only training exercise of its kind.

The Urban Shield exercise also encourages first responder training integration between Law Enforcement, Fire personnel, EMS, Hazardous Materials (Haz Mat) Teams, Search and Rescue, and civilian and private stakeholders. This training has paved the way for our SWAT team to train with other first responders in our county for increased responsiveness and communication interoperability.

Unfortunately, the potential for a terrorist attack and the inevitability of any number of natural disasters in our region must be considered. Individual agencies do not have the resources, nor the budget, to provide the training and experience that Urban Shield provides.

The Yellow Command Exercise scenarios sponsored through the Bay Area Urban Area Security Initiative, as part of Urban Shield, is an annual region-wide exercise that tests both City and County Emergency Operations Centers in realistic, scenario-based functional exercises. Each year, the Yellow Command exercise focuses on a response or capability gap in the region as it relates to Emergency Operations Center response. Over the past three years, Yellow Command tested mass fatality operations, response to an emergency at the Super Bowl, and in 2016, how to better manage logistics following a large earthquake in the Bay Area. The Yellow Command

training directly benefits and enhances EOC staff preparedness, Public Information Officer (PIO) collaboration, fatality management, mass casualty response, transportation and evacuation capabilities, and commodity Point of Distribution (POD) capabilities.

In 2014, Contra Costa hosted the regional mass fatality portion of Yellow Command which exercised the set-up for a Regional Disaster Mortuary Team and helped first responders and EOC personnel to better understand how to manage a mass fatality disaster. As you know, first responders were called upon to respond to a large warehouse fire in the City of Oakland with over 35 fatalities that tragically occurred in December of last year. The 2014 Yellow Command exercise directly benefited the City of Oakland and the County of Alameda by training responders for this type of real-world disaster.

As the Sheriff of Contra Costa County, I fully support the Urban Shield and Yellow Command Exercises. These exercises provide a platform for all hazard planning and allow emergency management personnel to be better prepared for future crises that could impact our region.

ring all of the above incidents the Incident Command System (ICS) was utilized by first responders. Planning, Operations, Communications, Logistics and Finance all need to work together especially when dealing with numerous agencies from different disciplines fire, law, and EMS since any of these incidents can easily overwhelm the resources of any one agency. The time to build relationships with other agencies should not occur during a disaster but rather during joint training exercises. This is the time to discuss best practices, learn what resources each other have to offer and find out what gaps need to be addressed.

Each Urban Shield scenario is based upon a real world event. Many of the scenarios will test the capabilities of the participants and first responders both mentally and physically. First responder leaders and elected officials need to know what areas we as a region need to improve on so we can ensure the safety of all of our communities. Urban Shield is the only training exercise that accomplishes this task. Many cities across the country have attended our Bay Area Urban Shield and have initiated their own. Boston Police Commissioner Edward Davis spoke before the Homeland Security Committee about the benefits his agency received when they sent their team to participate in Urban Shield.

As the training has gathered momentum the amount of civilian personnel that volunteer has increased to almost 3,000 in 2016. Many of them come back year after year and tell their friends to participate as well. This has been an excellent opportunity for all of our first responders to interact with members of the community and show them what we do to protect them on so many levels.

I encourage all of you go to the area command hosted by the San Francisco Police Department to see how they would handle multiple events simultaneously. As a region we have had the opportunity through our

blic/private partnerships to train on several of the identified critical infrastructure sites in the Bay Area. I would also recommend you come out to the Office of Homeland Security and Emergency Services in Dublin

where all of the events are being monitored and the administration portion of the Incident Command System is taking place.
