Motion appointing Laura Guzman (residency requirement waived), for the unexpired portion of four-year term ending October 21, 2019, and Sophia Isom (residency requirement waived), for the unexpired portion of four-year term ending October 21, 2018, to the Local Homeless Coordinating Board.

MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated persons to serve as members of the Local Homeless Coordinating Board, pursuant to the provisions of Resolution Nos. 827-97 and 926-99, for the terms specified:

Laura Guzman (residency requirement waived), seat 5 (formerly seat 1), succeeding herself, term expired, shall represent organizations or projects serving one or more of the following homeless subpopulations in San Francisco: families with children; single adults; veterans; the chronically homeless; unaccompanied youth; persons with HIV/AIDS; persons with substance use disorders; the seriously mentally ill; and victims of domestic violence, dating violence, sexual assault, and stalking, for the unexpired portion a four-year term ending October 21, 2019;

Sophia Isom (residency requirement waived), seat 7 (formerly seat 3), succeeding Kim Armbruster, resigned, shall represent organizations or projects serving one or more of the following homeless subpopulations in San Francisco: families with children; single adults; veterans; the chronically homeless; unaccompanied youth; persons with HIV/AIDS; persons with substance use disorders; the seriously mentally ill; and victims of domestic violence, dating violence, sexual assault, and stalking, for the unexpired portion of a four-year term ending October 21, 2018; and, be it

1. The membership of the Local Homeless Coordinating Board has a goal to be representative of the diversity of the City and County of San Francisco.

2. Applicants Laura Guzman and Sophia Isom, who are not residents of San Francisco, are persons with experience that uniquely qualifies them to serve on the Local Homeless Coordinating Board.

3. The Local Homeless Coordinating Board has attempted to fill the positions, for which Laura Guzman and Sophia Isom were nominated, with individuals who are City residents and who have the specific experience, skills, and qualifications, but have been unable to do so at this time. The Rules Committee has certified that Laura Guzman and Sophia Isom are qualified to serve on the Local Homeless Coordinating Board.

4. After exercising due diligence, the Board of Supervisors concludes that there are no other possible representatives, who are residents of San Francisco, and who have the specific experience, skills, or qualifications possessed by these applicants, and who are willing to serve on the Local Homeless Coordinating Board at this time; and, be it

I am a bilingual and bicultural Latina who is the founding director of the only homeless resource center in the Mission, which targets the Latino and immigrant communities impacted by homelessness - the only one that serves monolingual Spanish speakers in the City. As a trauma-survivor, I seek to represent communities who have been impacted by PTSD and the trauma of homelessness, which impact the large majority of the communities served by the LHCB. As a policy planner and leader of the LHCB, I have assisted the Board to meet HUD regulations and be in compliance, participate in two Five-Year plans, and helped increase federal funding to the SF Continuum of

compliance, participate in two Five-Year plans, and helped increase federal funding to the SF Continuum of Care, as it has held its position as one of the top-rated COCs in the country. In this new term, i will be chairing our Policy Committee, with the goal of assisting the City to identify, build and develop supportive housing and at the same time reduce anti-homeless laws, a new mandate by HUD and a necessary road to decrease criminalization, incarceration and ineffective use of funds. I am looking forward to this challenge.

My work with homelessness began when I was a student at Seint Ignatus College Prep and volunteered to work in Saint Anthony's Dining Room serving local homeless. While I was in college and law school, I followed the situation in San Francisco closely. When I graduated law school and began my work as an attorney in San Francisco. I decided that I wanted to do pro bono work, and I chose to volunteer for the Homeless Advocacy Project because homelessness is the issue that I care about most in San Francisco. As a pro bono volunteer with HAP, I have dealt with cases involving mental illness, criminal activity, and imminent homelessness. My main concern is with the mechanisms in San Francisco to deal with the chronically homeless who have mental illnesses. My experience is that It is very difficult to solve the problem of chronic homelessness without addressing the
underlying mental problems that these individuals have. Finally, as a long-time resident of San Francisco's Mission District, I have experienced all different kinds of demographic qualities that are in need of help. I grew up in a time when many of my neighbors were dying because of AIDS, and it was not until about 1996 that this stopped being a regular occurrence. This early experience with the suffering of a particular community left a great effect on me, and has prompted me to understand and realize the problems that disadvantaged communities face on a regular basis.

# Business and/or professional experience:

I am a litigation attorney in San Francisco, and I primarily do business and entertainment litigation. While this may not seem directly relevant to the issues of local homelessness, I believe the problem-solving and negotiation skills that I have developed would be essential to the problem-solving necessary to navigate the problems that San Francisco's homeless community face. I also think that it is important to have representatives from all different parts of San Francisco's society who are interested in helping the homeless.

## **Civic Activities:**

I am a pro bono voluneer for the Homeless Advocacy Project, where I do my best to prevent homelessness, and in one case dealt with a severely mentally ill man who was homeless, and after many attempts, finally got him the treatment that he needed. I dealt extensively with the City's mental health system and understand the problems and issues that it faces.

I also volunteer as a coach for Lincoln High School's Mock Trial team, where I coach kids from Lincoln in the fundamentals of advocacy.

#### **Board Qualifications:**

The Local Homeless Coordinating Board shall perform the following functions:

(a) Serve as the Continuum of Care governing body in accordance with applicable U.S. Department of Housing and Urban Development ("HUD") rules and regulations, including but not limited to 24 CFR Part 578 et seq., as amended. The Board shall adopt, and all members shall abide by, a written conflict of interest policy that complies with 24 CFR Part 578.95(b), as amended.

(b) Advise the Department of Homelessness and Supportive Housing on homeless policy and budget allocations.

The Coordinating Board shall hold a meeting not less than once every month. The Coordinating Board shall elect officers and shall establish rules or bylaws for its organization and procedures.

The Board shall consist of nine (9) members, as follows:

### The Board of Supervisors will appoint:

> Four (4) members from one of the following homeless subpopulations in San Francisco: families with children; single adults; veterans; the chronically homeless; unaccompanied youth; persons with HIV/AIDS; persons with substance use disorders; the seriously mentally ill; and victims of domestic violence, dating violence, sexual assault, and stalking. One Board member

may represent the interests of more than one homeless subpopulation.

The Mayor shall appoint:

> One (1) member who shall be a homeless or formerly homeless person; and
 > Three (3) members from one of the following homeless subpopulations in San Francisco:
 families with children; single adults; veterans; the chronically homeless; unaccompanied youth; persons with HIV/AIDS; persons with substance use disorders; the seriously mentally ill; and victims of domestic violence, dating violence, sexual assault, and stalking. One Board member may represent the interests of more than one homeless subpopulation.

> The Controller shall appoint one (1) member from one of the following homeless subpopulations in San Francisco: families with children; single adults; veterans; the chronically homeless; unaccompanied youth; persons with HIV/AIDS; persons with substance use disorders; the seriously mentally ill; and victims of domestic violence, dating violence, sexual assault, and stalking. One Board member may represent the interests of more than one homeless subpopulation.

The Director of the Department of Homelessness and Supportive Housing or Director's designee shall attend meetings of the Local Homeless Coordinating Board, established by Chapter 5, Article XXXI of the Administrative Code, and the Department shall provide administrative and clerical staffing as needed to the Local Homeless Coordinating Board and provide the Board with the information it requests in the exercise of its duties.

Each member of the Coordinating Board shall serve at the pleasure of the member's appointing authority for a term of four years.

(The Board of Supervisors amended the "Continuum of Care Plan" to incorporate the recommendations of the Ad Hoc Committee's proposal and disbanded the original Local Board, effective August 1, 2005. A new "Local Homeless Coordinating Board" was reconstituted, effective August 1, 2005, with nine members - Resolution No. 208-05. On June 28, 2016, the Board of Supervisors passed Ordinance No. 116-16, which amended the Aministrative Code to establish the Local Homeless Coordinating Board. The ordinance established new seat qualifications and duties.)
