

15 Be it ordained by the People of the City and County of San Francisco:

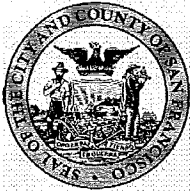
16 Section 1. The Board of Supervisors hereby adopts and implements Amendment No. 1




