1 [Urging the Department of Public Health to Provide Treatment for HIV-related Lipodystrophy
2 Syndrome and Supporting California Senate Bill 221 (Wiener)]

3 **Resolution calling on the Department of Public Health to provide access to treatment
4 and coverage for HIV-related lipodystrophy syndrome; and supporting California State
5 Senate Bill 221, authored by Senator Wiener, to require insurance providers in
6 California to cover medical treatment for HIV-related lipodystrophy syndrome.**

8 WHEREAS, San Francisco has long-been internationally recognized as a leader in the
9 treatment and care of patients with HIV/AIDS; and

10 WHEREAS, The advancement of medical science over the years has significantly
11 improved the efficacy of HIV treatment, leading to longer, healthier, and more fulfilling lives;
12 and

13 WHEREAS, Improved treatment options including antiretroviral drug therapy have
14 made HIV a long-term manageable disease, leaving patients to cope with other associated
15 diseases, including lipodystrophy syndrome; and

16 WHEREAS, Lipodystrophy syndrome is a disturbance of fat metabolism that involves
17 the abnormal deposition and distribution of fat in the body, with some areas of the body
18 missing subcutaneous fat altogether and with other areas suffering large deposits; and

19 WHEREAS, Severe lipodystrophy is also a manifestation of insulin resistance and is
20 associated with highly elevated triglyceride levels and fatty liver disease; and

21 WHEREAS, Lipodystrophy syndrome creates visible disfiguring and stigmatizing
22 morphological changes in body shape and appearance, often including a fat pad on the neck
23 (colloquially called "buffalo hump"), fat accumulation around the front of the neck and under
24 the chin (colloquially called "horse collar"), increased abdominal girth, and abnormal fat loss in
25 the nasolabial folds of the face as well as in the limbs; and

1 WHEREAS, In addition to the physical impacts, lipodystrophy also causes severe
2 psychological harm to people with HIV; and

3 WHEREAS, Although lipodystrophy syndrome is clearly associated with HIV and
4 inexpensive and effective medical treatments currently exist, insurers routinely deny claims for
5 treatment on the basis that they are cosmetic and not medically necessary; and

6 WHEREAS, In 2016, the Commonwealth of Massachusetts became the first State in
7 the nation to require that public and private insurance providers cover medical treatments for
8 HIV-associated lipodystrophy; and

9 WHEREAS, Most insurance and medical care providers in California, including private
10 carriers and Medi-Cal, consider HIV-related lipodystrophy as a cosmetic issue and therefore
11 do not provide coverage for treatment; and

12 WHEREAS, Healthy San Francisco and the San Francisco Health Service System do
13 not cover, or provide access to treatment, for HIV related lipodystrophy; and

14 WHEREAS, California State Senator Wiener has introduced Senate Bill 221, which
15 would mandate that treatment for HIV-related lipodystrophy syndrome be covered in California
16 by both public and private insurance providers; now, therefore, be it

17 RESOLVED, That the Board of Supervisors, consistent with our shared values of being
18 a world-leader in the treatment and care of HIV/AIDS patients and for the continued advocacy
19 on their behalf, strongly urges the Department of Public Health to take the necessary steps to
20 ensure that patients enrolled in Healthy San Francisco who suffer from HIV-related
21 lipodystrophy are provided with access to care; and, be it

22 FURTHER RESOLVED, That the Board of Supervisors strongly supports California
23 Senate Bill 221 (Wiener); and, be it

1 FURTHER RESOLVED, That the Board of Supervisors requests that the Clerk of the
2 Board transmit the final approved resolution to the State Legislature and to the Department of
3 Public Health.
