10	Be it ordained by the People of the City and County of San Francisco:
11	
12	Section 1. The Police Code is hereby amended by adding Article 13.4, entitled
13	"Reducing Rental-Car Burglaries," consisting of Sections 977.1 through 977.8, to read as
14	follows:
15	
16	ARTICLE 13.4: REDUCING RENTAL-CAR BURGLARIES
17	
18	SEC. 977.1. FINDINGS.
19	(a) San Francisco faces a severe automobile-burglary crisis. In 2015, the City experienced
20	approximately 25,000 such burglaries—roughly 70 a day. The City experienced a similar number of
21	automobile burglaries in 2016. Automobile burglaries have nearly tripled since 2011, when San
22	Francisco experienced approximately 10,000 such burglaries.
23	(b) Automobile burglaries pose a grave threat to the safety and security of San Francisco's
24	residents. San Francisco's Civil Grand Jury estimated that property worth approximately \$19 million
25	was stolen from cars in San Francisco in 2015. This lucrative revenue stream attracts organized

11 (d) San Francisco attracts large numbers of tourists, business travelers, and other visitors fr	<u>om</u>
12 <u>all over the world. Visitors contribute significantly to the City's economy. To maintain San</u>	
13 <i>Francisco's status as a major destination for tourists and other visitors, and to continue to reap the</i>	
14 <u>economic benefits that visitors provide, the City has a vital interest in ensuring that visitors have say</u>	<u>e,</u>
15 <u>successful, and positive experiences when visiting San Francisco.</u>	
16 (e) Data from the District Attorney's Office shows that many of San Francisco's biggest tour	<u>ist</u>
17 <u>destinations—Alamo Square Park, the Embarcadero, Fisherman's Wharf, Civic Center, Lombard</u>	
18 <u>Street, the Palace of Fine Arts—are major hotspots for automobile burglary</u> . Visitors to San France	<u>sco</u>
19 <i>are especially attractive targets for those who commit automobile burglary, because—as the Civil</i>	
20 Grand Jury has found, and as the Police Department has advised—they are especially vulnerable to	it.
21 <u>Would-be burglars know that many visitors are carrying large amounts of money, electronics, and</u>	
22 <u>other valuables.</u> Further, many visitors are unfamiliar with San Francisco and its hazards, and may	<u>'</u>
23 <u>face special linguistic and cultural barriers</u> . Moreover, visitors may be unable or unwilling to initid	<u>te</u>
24 <i>a police investigation in a city that is foreign to them and where they will not long remain, and they</i>	<u>are</u>
25 <u>often unable to return to San Francisco to testify in criminal prosecutions of suspected burglars.</u>

1	(f) The City has launched a series of public-education campaigns designed to reduce
2	automobile burglaries by warning visitors about the risks of such burglaries. Signs warning drivers to
3	remove valuables from their cars have been installed near tourist hotspots like Fisherman's Wharf,
4	Alamo Square, Japantown, and the Palace of Fine Arts. San Francisco International Airport has
5	posted signs at its Rental Car Center warning visitors of the risks of leaving valuables in rental
6	vehicles, and has also provided rental-car companies with written warnings to distribute to customers.
7	An announcement warning visitors about automobile burglary is also played on the AirTrain
8	connecting airport terminals to the Rental Car Center. The Police Department, additionally, is
9	working with local hotels and businesses to ensure that visitors are warned of the risks of automobile
10	<u>burglary.</u>
11	(g) In addition to educating visitors about the risks of automobile burglary, making automobile
12	burglary more difficult and less attractive requires addressing one central reason that visitors are
13	especially vulnerable to automobile burglary: many of them drive easily identifiable rental cars. As the
14	Police Department has advised, automobile burglars specifically target vehicles that are identifiable as
15	rental cars. Reducing the identifiability of vehicles as rental cars would, therefore, directly address the
16	<u>City's automobile-burglary crisis.</u>
17	(h) Rental cars in San Francisco are easily identifiable as such. Unlike other vehicles, rental
18	cars typically carry barcode stickers on their windshields and windows. Many rental cars also carry
19	advertisements—for example, license-plate frames—promoting the companies from which they are
20	<u>rented.</u>
21	(i) Eliminating these barcodes and advertisements would not significantly burden rental-car
22	companies. Although rental-car companies use windshield and window barcodes to track their
23	inventory, they could easily track their inventory in other ways. For example, rental-car companies
24	could place barcodes in places that were not immediately visible (such as inside vehicle doors), or use
25	other non-visible means of inventory control (such as radio-frequency identification, or RFID).

1	Likewise, rental-car companies can, and do, advertise their vehicles in many ways that do not involve
2	placing advertisements on the exteriors of the vehicles themselves, such as massive advertising on
3	television, in print media, and via the Internet.
4	(j) Eliminating these barcodes and advertisements would directly address San Francisco's
5	automobile-burglary crisis. Visitors to San Francisco are particularly vulnerable to automobile
6	burglary, and making their rental cars less conspicuous is an important way for the City to make
7	visitors less vulnerable. By making it more difficult for would-be burglars to target visitors' rental
8	cars, eliminating rental-car barcodes and advertisements would significantly help to combat the City's
9	automobile-burglary crisis.
10	
11	SEC. 977.2. DEFINITIONS.
12	For purposes of this Article 13.4, the following definitions apply:
13	"Automobile" means any self-propelled, four-wheeled motor vehicle, designed for use
14	principally upon streets and highways, and used chiefly for transporting persons and their personal
15	belongings. It includes pickup trucks, but does not include any other kind of truck.
16	<u>"Barcode" means an optical, machine-readable code that uses any pattern of lines or shapes</u>
17	with or without accompanying letters, numbers, or other symbols—to convey information. It includes,
18	but is not limited to, QR codes and other "two-dimensional" codes, in addition to "one-dimensional,"
19	<u>line-based codes.</u>
20	"City" means the City and County of San Francisco.
21	"Rental Company" means any entity that offers any Automobile for rent, but does not include
22	any "car-share service" or "certified car-share organization" as defined in Section 166 of the
23	<u>Planning Code.</u>
24	
25	

1	SEC. 977.3. GEOGRAPHIC SCOPE OF ARTICLE.
2	Except as provided in Section 977.6, this Article 13.4 does not apply outside the geographic
3	boundaries of the City.
4	
5	SEC. 977.4. RENDERING RENTAL CARS LESS CONSPICUOUS.
6	(a) Visible Barcodes prohibited. Except as provided in subsection (c), no Automobile may be
7	rented if the Automobile contains a Barcode affixed to any of the following:
8	(1) The windshield or rear window:
9	(2) Any other window;
10	(3) Any part of the Automobile's exterior other than the undercarriage; or
11	(4) Anything that is itself affixed to a location identified in subsections (a)(1)-(3).
12	(b) Visible advertising prohibited. Except as provided in subsection (c), no Automobile may be
13	rented if the Automobile's exterior, or anything that is itself affixed to the exterior, contains any of the
14	<u>following:</u>
15	(1) The Rental Company's name;
16	(2) Any identifying slogan used by the Rental Company;
17	(3) Any identifying mark used by the Rental Company;
18	(4) Any address, phone number, e-mail address, website address, or other contact
19	information used by the Rental Company;
20	(5) The words "rent" or "rental," or any variation thereof; or,
21	(6) Any other advertisement for the Rental Company.
22	(c) Exclusions. This Section 977.4 shall not apply to any Barcode that was installed by the
23	Automobile's manufacturer, or to a Barcode or anything else affixed to the automobile to comply with
24	any City, State, or Federal law.
25	

1	(d) Rental requires physical presence. An Automobile is not deemed to have been "rented"
2	within the meaning of this Section 977.4 until after a person seeking to rent the Automobile physically
3	presents himself or herself to the Rental Company.
4	(e) Obligation on Rental Company. It shall be the legal obligation of every Rental Company to
5	ensure that no Automobile is rented unless it complies with the requirements of this Section 977.4. No
6	person or entity other than a Rental Company—including, but not limited to, any customer of a Rental
7	Company, or any employee or agent of a Rental Company in his or her personal capacity—shall incur
8	any obligation under this Section.
9	(f) Operative date for this Section 977.4. Compliance with this Section 977.4 shall not be
10	required until 60 days after the effective date of this Article 13.4.
11	
12	SEC. 977.5. PERMIT CONDITION.
13	Beginning 60 days after the effective date of this Article 13.4, compliance with the obligations
14	imposed by Section 977.4 shall be a material condition of any permit obtained under Section 1227 of
15	this Police Code. Failure to comply with any obligation imposed by Section 977.4 shall be cause to
16	suspend or revoke or otherwise take action on any such permit.
17	
18	SEC . 977.6. APPLICATION TO CAR RENTALS AT SAN FRANCISCO INTERNATIONAL
19	<u>AIRPORT.</u>
20	(a) Incorporation into airport agreements. The requirements of Section 977.4 shall be
21	incorporated into any written agreement between the City and a Rental Company concerning the
22	Rental Company's operations at San Francisco International Airport—including, but not limited to,
23	any lease for the use of real property at San Francisco International Airport—executed after the
24	effective date of this Article 13.4. But, consistent with Section 977.4(f), such agreements shall not
25	impose the obligation to comply with Section 977.4 until 60 days after the effective date of this Article.

1	Beginning 60 days after the effective date of this Article, violation of the requirements of Section 977.4
2	shall be a material breach of such agreements, and shall render a Rental Company liable for liquidated
3	damages as described in subsection (b).
4	(b) Liquidated damages. Every agreement described in subsection (a) shall provide for
5	liquidated damages for any breach described in subsection (a), in an amount not less than \$100 and
6	not more than \$500 per each transaction that violates the requirements of Section 977.4.
7	
8	SEC. 977.7. UNDERTAKING FOR THE GENERAL WELFARE.
9	In enacting and implementing this Article 13.4, the City is assuming an undertaking only to
10	promote the general welfare. It is not assuming, nor is it imposing on its officers and employees, an
11	obligation for breach of which it is liable in money damages to any person who claims that such breach
12	proximately caused injury.
13	
14	<u>SECTION 977.8. SEVERABILITY.</u>
15	If any section, subsection, sentence, clause, phrase, or word of this Article 13.4, or any
16	application thereof to any person or circumstance, is held to be invalid or unconstitutional by a
17	decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining
18	portions or applications of the Article. The Board of Supervisors hereby declares that it would have
19	passed this Article and each and every section, subsection, sentence, clause, phrase, and word not
20	declared invalid or unconstitutional without regard to whether any other portion of this Article or
21	application thereof would be subsequently declared invalid or unconstitutional.
22	
23	Section 2. Effective Date. This ordinance shall become effective 30 days after
24	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
25	

1	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
2	of Supervisors overrides the Mayor's veto of the ordinance.
