3 **Ordinance authorizing settlement of the plaintiff's claim for attorney's fees and costs in**  
4 **the lawsuit filed by Protect Our Benefits against the City and County of San Francisco**  
5 **for \$750,000; the lawsuit was filed on February 25, 2013, in San Francisco Superior**  
6 **Court, Case No. CPF-13-512788; entitled Protect Our Benefits v. City & County of San**  
7 **Francisco; the lawsuit involves Supplemental Cost of Living Adjustment pension**  
8 **benefits payable to San Francisco Employees' Retirement System retirees.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the claim for attorney's fees and costs in the action  
13 entitled Protect Our Benefits v. City & County of San Francisco, San Francisco Superior  
14 Court, Case No. CPF-13-512788 by the payment of \$750,000.00. The lawsuit involves  
15 Supplemental Cost of Living Adjustment pension benefits payable to San Francisco  
16 Employees' Retirement System retirees.

17 Section 2. The above-named action was filed in San Francisco Superior Court on  
18 February 25, 2013, and the following parties were named in the lawsuit: Protect Our Benefits  
19 and the City & County of San Francisco.


