12 San Francisco, San Francisco Superior Court, Case No. CGC-15-547872 by the payment of
13 \$75,000. The lawsuit involves alleged personal injury on a City street.

15 September 10, 2015, and the following parties were named in the lawsuit: Plaintiff: Leslie


