DPW Order No: 181907

The Director of Public Works held a Public Hearing on Wednesday, August 7, 2013, at 9:00AM in Room 400 of City Hall. The hearing was to consider the validity of notices to repair that were issued to various property owners and utility agencies for the restoration of public right-of-way sidewalks as part of the City's Sidewalk Inspection & Repair Program (SIRP). The notices to repair under consideration were sent to the blocks in the Golden Gate Heights neighborhood bordered by:

SIRP 65 Golden Gate Heights A, bordered by
Quintara / Mendoza Avenue on the North;
9th Avenue / 14th Avenue on the East;
9th Avenue / San Marcos / Rivera / Taraval on the South, and
16th Avenue on the West

Based upon the facts submitted at the hearing, the findings and recommendation to the director are, as follows:

FINDINGS:

- Notice-to-repair letters to affected property owners and utility agencies were mailed out on July 26, 2013
- The department received one appeal to these notice-to-repair letters, NTR 992305, issued to the property owner, Mr. Thomas Medin, at 2179 12th Avenue, Block 2205, Lot 012, as stated below:
- Mr. Medin asserts that since the sidewalk tree was preexisting at the time of the property's purchase, that the fronting property owner was not responsible for its maintenance, or for damage to the sidewalk caused by the roots
- A search of the Department's tree database indicates that the tree is maintained by the fronting property owner, as well as the sidewalk damage caused by the tree
- Mr. Medin's assertion of the tree preexisting their purchase of the property does not invalidate DPW Codes 706 and 805 requiring property owners to maintain the sidewalks and street trees fronting their properties



HEARING OFFICER RECOMMENDATION:

After consideration of the above findings, the recommendation is to determine that all of the issued or mailed notice-to-repair letters are valid.

By signing this order, the Director approves of the above recommendation as his decision. Per Public Works Code, Article 15, Section 706.4 (c, d, e), and Public Works Code, Article 16, Section 805 (a), the Director's decision on this matter is final and is not appealable.

2. We came to the Board of Supervisors meeting over a year ago to object to the work.

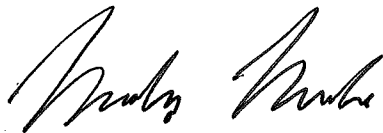

Pursuant to the provisions of Public Works Code, Section 706.9 and Administrative Code, Section 80, the Director of Public Works did cause the correction of sidewalk conditions at various locations where the obligation to perform such correction is that of the property owners.

At the public hearing, the Board of Supervisors will hear objections which may be raised by any property owner liable to be assessed, and may make such corrections, revisions or modifications to the report as it deems just. Confirmation of the report by the Board of Supervisors will result in special assessments of the property and addition of these assessments to the tax roll.

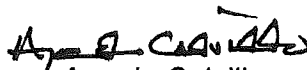
