
Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Leslie Stewart v. City and County of San Francisco, San Francisco Superior Court, Case No. CGC-15-547872 by the payment of \$75,000. The lawsuit involves alleged personal injury on a City street.
