[Settlement of Lawsuit - Maryam Mozafari - \$70,000]

Ordinance authorizing settlement of the lawsuit filed by Maryam Mozafari against the City and County of San Francisco for \$70,000; the lawsuit was filed on June 16, 2015, in San Francisco Superior Court, Case No. CGC-15-546389; entitled <u>Maryam Mozafari v.</u> <u>City and County of San Francisco</u>; the lawsuit involves alleged personal injury on a City sidewalk adjacent to Alta Plaza Park.

Be it ordained by the People of the City and County of San Francisco:
